# **CROATIAN GENERAL NATIONAL MARKET SURVEILLANCE PROGRAMME FOR 2014**

## **1. Introduction**

This document is the Croatian annual general National Market Surveillance Programme for the sectors covered by community harmonization legislation as required by Article 18(5) of Regulation (EC) No. 765/2008, setting the requirements for accreditation and market surveillance relating to the marketing of products and repealing Regulation (EEC) No 339/93.

The program covers Market Surveillance programs of the all competent Authorities in Croatia for non-food products within the scope of this regulation.

## **2. General objectives of Market Surveillance**

The objective of the market surveillance framework of the products set out in the regulation is to ensure that those products fulfill requirements providing high level of protection of public interests, such as general health and safety and consumer protection. In the sense, the market surveillance overall aims is to ensure that only safe products circulate in community market.

This achievement is ensured by control and surveillance procedures and proactive methods as well as reactive ones. If the product presents a risk, it is necessary to adopt appropriate measure (withdrawal, recall, etc.) and to inform the public, the Commission and the Member States.

## **3. Organization of Market Surveillance in Croatia**

In Croatia there are several Authorities competent for Market Surveillance of different products in frame of the Regulation (EC) No. 765/2008 and they have to cooperate in their activities and synchronize their plans and programs as specified in the Act on the State Administration System. They work as Market Surveillance inspections within different ministries according to the type of the product.

The market surveillance authorities and their competence areas are as follows:

1. Market Inspection, sector of the Economic Inspections Directorate, in the Ministry of Economy is a general Market Surveillance authority in the field of consumer protection on the internal market for non-food products (for example: electrical equipment, electromagnetic compatibility, energy labeling, textile products, personal protective equipment, the production and placing and making available on the market construction products while construction products in use are in the scope of the Building Inspection of the Ministry of Construction and Physical Planning, etc.).

2. Ministry of Health:

a) Directorate for Sanitary inspection is supervising compliance of general use items, cosmetic products, toys, tobacco and products that come in contact with food, manufacturing, sale, use and treatment of chemicals.

b) Health Protection Directorate, Pharmaceutical Inspection controls medicinal products and medical devices.

3. The Croatian Post and Electronic Communications Agency (HAKOM) is supervising radio and telecommunication terminal equipment in use and placed on the market.

4. Ministry of Maritime Affairs, Transport and Infrastructure, the Maritime Safety Directorate is controlling recreational crafts, while Cableway Inspection controls passenger cableways.

5. Market Surveillance of explosive substances is supervised by Ministry of Interior, Inspection of Production and Traffic of Explosive Substances, while the ATEX Directive is under control of Inspection for Fire Protection, Labour Inspection, Electric power Inspection and Mining Inspection.

6. State Office for Metrology, Service for Metrological Inspection is supervising administrative and professional tasks referring to official measurements, control of legality of work of authorized legal entities, authorized services and users of legal measuring instruments and monitoring and surveillance of the situation in the field of legal metrology and undertaking measures for good quality activity performance, control of precious metals articles and type approval of vehicles.

#### **4. Priorities**

Contact point in Croatia for the RAPEX system has been established in Ministry of Economy which coordinates all other market surveillance authorities (Ministry of Health, Ministry of Maritime Affairs, Transport and Infrastructure, Ministry of Interior, Ministry of Finance – Customs and State Office for Metrology). The contact point has started with its work in July 2013.

Croatia is also using ICSMS since 2013. The most active user of the system is Ministry of Economy – Market Inspection. Also the other competent inspection authorities have started with using the system.

The following activities will be prioritized in 2014:

- Strengthening cooperation among different inspection and customs authorities,
- Encouraging the active use of the ICSMS and RAPEX system according to the article 23 and article 22 of the Regulation (EC) No. 765/2008,
- Preparation for challenges from the new EU legislation (Product Safety and Market Surveillance Package).

Detailed sector plans of different surveillance authorities are attached to this document.
