SUMMARY RECORD

10TH MEETING OF THE MANAGEMENT COMMITTEE FOR THE COMMON ORGANISATION OF AGRICULTURAL MARKETS 14-15 APRIL 2008

As there was an unexpected vote on a Single CMO regulation during the Cereals meeting on Thursday 10th April, this meeting is now the 10th meeting of the Committee and not the 9th, as announced in the Convocation.

Chairman: Mr Russell MILDON

27 delegations were present and took part in the votes.

1. PROPOSED MEASURES ON WHICH AN OPINION MAY BE REQUESTED UNDER THE PROCEDURE PROVIDED FOR IN ARTICLE 195(2) OF COUNCIL REGULATION (EC) NO 1234/2007

1.1 Fruit and Vegetables

1.1 *Règlement (CE) N°.../2008 de la Commission du modifiant le règlement (CE) n° 1580/2007, en ce qui concerne les volumes de déclenchement des droits additionnels pour les tomates, les abricots, les citrons, les prunes, les pêches, y compris les brugnon et nectarines, les poires et les raisins de table.*

Regulation adjusting the trigger level for additional duties on tomatoes, apricots, lemons, plums, peaches, including nectarines, pears and table grapes. The adjustment is made in the light of the latest available data and complies with the criteria laid down in Article 5 of the Agreement on Agriculture (Uruguay Round).

⇒VOTE: unanimously in favour
