**1. DISCUSSION AND OPINION ON THE DRAFT COMMISSION REGULATION LAYING DOWN DETAILED RULES FOR THE APPLICATION OF COUNCIL REGULATION (EC) NO 3/2008 ON MEASURES TO PROVIDE INFORMATION ON, AND TO PROMOTE AGRICULTURAL PRODUCTS**

The Commission introduces the draft Commission Regulation implementing Council Regulation 3/2008 by merging the two existing Regulations for the Internal Market (1071/2005) and Third Countries (1346/2005).

Linguistic remarks can be sent to the Commission by Friday 25 June 2008.

The committee's vote gives an opinion in favour on the draft Commission Regulation (326 for, zero against, 7 abstentions and 12 not represented).
