149TH MEETING OF THE MANAGEMENT COMMITTEE FOR THE COMMON ORGANISATION OF AGRICULTURAL MARKETS (HORIZONTAL QUESTIONS) OF 13 NOVEMBER 2009

24 MS were present; CY, LU and MT were absent; for the vote CY was represented by PL, LU by BE and MT by the UK

1. DRAFT COMMISSION REGULATION LAYING DOWN COMMON DETAILED RULES FOR THE IMPLEMENTATION OF COUNCIL REGULATION (EC) NO 1234/2007 AS REGARDS BUYING-IN AND SELLING OF AGRICULTURAL PRODUCTS UNDER PUBLIC INTERVENTION:

A revised draft Regulation laying down implementing rules on public intervention was presented to delegations.

It aims to create a horizontal instrument for buying-in and sales of cereals, rice, meat and dairy products and to take into account the outcome of the "health check", harmonise rules and abolish a number of sector regulations.

Result of the vote:

No opinion (249 in favour (18 MS), 37 against (5 MS) and 59 abstentions (4 MS)

2. EXCHANGE OF VIEWS ON THE APPLICATION OF ARTICLE 17 OF REGULATION (EC) NO 612/2009:

No new items raised.

3. PRESENTATION OF A WORKING DOCUMENT ON THE MODIFICATION OF CERTAIN REGULATIONS ON THE FORM OF THE NOTIFICATIONS TO BE SENT TO THE COMMISSION

This Regulation provides that some notification obligations established by Regulations (EC) No 2336/2003, (EC) No 341/2007, (EC) No 1580/2007 and (EC) No 376/2008 have to be sent via an informatics system established in conformity with Regulation (EC) No 792/2009 (ISAMM) from 1st of February 2010.

4. AOB:

COM distributed an updated list of exit points and contact persons for the export of live b bovine animals (application of Regulation (EC) No 639/2003). Due to a lack of agreement

of the contact persons in certain MS it is not possible to publish the list on CIRCA. MS are invited to send their remarks for a further update of the list

COM informed Member States that the draft of the export refund nomenclature (ERN) was made available in CIRCA in all languages. MS are invited to give possible remarks until 20 November 2009 at the latest.
