SUMMARY RECORD

15TH MEETING OF THE MANAGEMENT COMMITTEE FOR THE COMMON ORGANISATION OF AGRICULTURAL MARKETS "HORIZONTAL QUESTIONS" OF 6 MAY 2008

Chair: Mr. VERSTEIJLEN/ Ms SIRACUSA

27 delegations were present.

1. Draft Commission Regulation amending Regulation (EC) No /2008 [1291 as codified] laying down common detailed rules for the application of the system of import and export licences and advance fixing certificates for agricultural products, as well as Regulations (EC) No 1439/95, (EC) No [1445/95 as codified], (EC) No 245/2001, (EC) No 2535/2001, (EC) No 1342/2003, (EC) No 2336/2003, (EC) No 1345/2005, (EC) No 951/2006, (EC) No 1918/2006, (EC) No 341/2007 and (EC) No 1580/2007:

The products for which export or import licenses are required are listed in the basic regulations (Council Regulations) of each market organisation. Since those regulations are to be repealed pursuant to Article 201 of Regulation (EC) No 1234/2007, horizontal provisions should be established as from the dates of application of Regulation (EC) No 1234/2007 as provided for in Article 204 of that Regulation.

Result of the vote: favourable opinion (291 in favour; 27 against; 27 abstentions)

2. WORKING DOCUMENT ON A DRAFT REGULATION AMENDING REGULATION (EC) NO 1501/95 AND REGULATION (EC) NO 800/1999 AS REGARDS THE CONDITIONS OF GRANTING EXPORT REFUNDS ON AGRICULTURAL PRODUCTS (EC ORIGIN):

In accordance with Article 162 of Regulation (EC) No 1234/2007 products listed in that article to be exported with or without further processing may be eligible to export refunds if they comply with specific conditions laid down in Article 167 of the said Regulation. Moreover, Article 167(7) of Regulation (EC) No 1234/2007 gives the possibility to the Commission to establish further conditions for the granting of export refunds for one or more products. Those conditions are currently laid down in the Council regulations on the common organisation of the market in the sectors listed Article 162(1) of Regulation (EC) No 1234/2007. Since those regulations are to be repealed pursuant to Article 201 of Regulation (EC) No 1234/2007, horizontal provisions should be established as from the dates of application of Regulation (EC) No 1234/2007 as provided for in Article 204 of that Regulation.

Result of the vote: favourable opinion (291 in favour; 54 abstentions)
