1. PROPOSED MEASURES ON WHICH AN OPINION MAY BE REQUESTED OF REGULATION (EC) No 288/2009

- 1.1 Derogation from Regulation (EC) No 288/2009 as regards the deadline for Member States to notify their strategies to the Commission and the deadline for the Commission to decide on the final allocation of the aid in the framework of a School Fruit Scheme

The Committee voted on the draft Regulation and delivered a favourable opinion by 26 votes in favour (333), 1 abstention (12)
