187th MEETING OF THE MANAGEMENT COMMITTEE FOR THE COMMON ORGANISATION OF AGRICULTURAL MARKETS (HORIZONTAL QUESTIONS) OF 5th OF MAY 2010

Chair: Mr VERSTEIJLEN/Mrs SIRACUSA

26 MS were present; MT was absent and represented by UK for the vote

1. DRAFT COMMISSION REGULATION AMENDING REGULATION (EC) NO 826/2008 LAYING DOWN COMMON RULES FOR THE GRANTING OF PRIVATE STORAGE AID FOR CERTAIN AGRICULTURAL PRODUCTS:

Since the reference to Regulation (EC) No 105/2008 in point III of Annex I to Regulation (EC) No 826/2008 is no longer relevant starting with 1 March 2010, for reasons of clarity it is therefore appropriate to update this reference by making reference to points 1.(a), (b) and (c) of Part III of Annex IV to Regulation (EU) No 1272/2009.

Result of the vote: favourable opinion (338 in favour, 7 abstentions)

2. EXCHANGE OF VIEWS ON A WORKING DOCUMENT RELATING TO POSSIBLE AMENDMENTS TO COMMISSION REGULATION (EC) NO 1272/2009 ON PUBLIC INTERVENTION :

The aim of the proposal is to correct certain errors that appeared after publication and update the references of certain norms referred to in the annexes.

3. DRAFT COMMISSION REGULATION AMENDING SEVERAL SECTORAL REGULATIONS AS REGARDS THE FORM OF NOTIFICATIONS TO BE MADE TO THE COMMISSION (ISAMM):

This Regulation provides that some notification obligations established by Regulations (EC) No 1518/2003, (EC) No 596/2004, (EC) No 633/2004, (EC) No 1345/2005, (EC) No 2014/2005, (EC) No 239/2007 (EC), No 1299/2007, (EC) No 543/2008 , (EC) No 589/2008, (EC) No 617/2008 and (EC) No 826/2008 08 have to be sent by using an informatics system established in conformity with Regulation (EC) No 792/2009.

4. EXCHANGE OF VIEWS CONCERNING A REVIEW OF REGULATION (EC) NO 612/2009 (PROOF OF EXIT OF THE COMMUNITY'S CUSTOMS TERRITORY, EXPORT PROCEDURE, AND PROOF OF ARRIVAL- SEE NEXT AGENDA POINT):

COM outlined its approach in order to have a structured discussion concerning the update of the said regulation on basis of specific proposals made by Member States.

5. EXCHANGE OF VIEWS ON THE APPLICATION OF ARTICLE 17 OF REGULATION (EC) NO 612/2009: REPORTING BY DELEGATES OF THEIR PROGRESS IN RESEARCH TO THE POSSIBLE USE OF BANK PAYMENT CONFIRMATION, THE APPLICATION IN THEIR MS OF THE "ICC NEW ROLES ON DOCUMENTARY CREDITS 2007", THE NATIONAL LEGISLATION AS A BASIS FOR POSSIBLE ADDITIONAL VALUE OF THE JOURNAL IN AN ENTERPRISE'S BOOK KEEPING TO BANK PAYMENTS AND NON-CERTIFIED PADOF VIEWS CONCERNING A REVIEW OF REGULATION (EC) NO 612/2009 (PROOF OF EXIT OF THE COMMUNITY'S CUSTOMS TERRITORY, EXPORT PROCEDURE, AND PROOF OF ARRIVAL- SEE NEXT AGENDA POINT):

Commission made some preliminary observations on certain proposals concerning additional proofs of arrival in case of electronic customs documents. MS presented their studies on certain alternatives.

6. AOB:

A notice concerning the reorganisation of unit D 3 was distributed to Member States reminding them that unit D 3 has become C 1 as from **1st July 2008**. However a considerable number of mail concerning unit C 1 matters continues to be addressed to the functional mailbox of unit D 3. Member States are invited to adapt their IT systems accordingly.

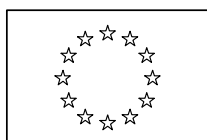

7. COMMISSION DECISION AUTHORISING FINLAND TO STOCK 140 000 TONNES OF CEREALS FROM THE 2009/2010 CAMPAIGN OUTSIDE ITS TERRITORY

Taking into account the storage capacity available in Finland, the possibility must be considered of storing part of the cereals taken over into intervention in Finland during the 2009/2010 marketing year in other Member States, at the request of and under the responsibility of the Finnish intervention agency.

Result of the vote: favourable opinion (316 in favour, 29 abstentions)
