**19TH MEETING OF THE MANAGEMENT COMMITTEE FOR THE COMMON
ORGANISATION OF AGRICULTURAL MARKETS
(HORIZONTAL QUESTIONS) OF 22 MAY 2008**

Chair: Ms SIRACUSA

25 delegations were present; Greece and Latvia were absent.

1. Working document: Draft Commission Regulation laying down common rules for the granting of an aid for private storage for certain agricultural products:

Currently, the possibility of granting aid for private storage is laid down in the Council Regulations on the common organisation of the markets in certain products. These regulations are replaced by Council Regulation (EC) 1234/2007.

In order to simplify and improve the effectiveness of the management and control mechanisms, common rules should be laid down for the implementation of the private storage aid scheme.

2. A.O.B.:

COM informed Member States that they will be consulted to endorse the Global Implementation Plan (GIP) for ISAMM.

Member States were informed that it may be necessary to convene a meeting of the agrimonetary committee concerning a possible adaptation of Regulation (EC) No 1913/2006 in the wine sector.
