OF THE 26th MEETING OF THE
MANAGEMENT COMMITTEE FOR THE COMMON ORGANISATION
OF AGRICULTURAL MARKETS
(IN THE MARGIN OF THE MANAGEMENT COMMITTEE FOR WINE)
OF 23 JUNE 2008**

Delegations: All delegations were present, except Latvia, Lithuania and Malta

TOBACCO:

- 1) **VOTE ON A DRAFT COMMISSION REGULATION LAYING DOWN DETAILED RULES FOR IMPLEMENTING COUNCIL REGULATION (EC) NO 1234/2007, AS REGARDS INTERBRANCH ORGANISATIONS AND AGREEMENTS IN THE TOBACCO SECTOR.**

As certain provisions laid down in Council Regulation (EEC) No 2077/92, which will be repealed, and in its implementing Commission Regulation (EEC) No 86/93 on interbranch organisations and agreements in the tobacco sector have not been incorporated in Regulation (EC) No 1234/2007, a new Regulation became necessary in the interest of clarity and rationalisation and in order to enable the tobacco sector to continue to function properly; Regulation (EEC) No 86/93 will also be repealed.

Vote: Favourable opinion (331 in favour, 14 not represented)

HOPS:

- 1) **VOTE ON A DRAFT COMMISSION REGULATION AMENDING REGULATION (EC) NO 1299/2007 ON THE RECOGNITION OF PRODUCER GROUPS FOR HOPS.**

As Council Regulation (EC) No 1952/2005 concerning the common organisation of the market in hops will be repealed and as certain provisions relating to hop producer organisations have not been incorporated and specified in Regulation (EC) No 1234/2007 (Single CMO Regulation), it is necessary to lay down those provisions in Commission Regulation (EC) No 1299/2007 on the recognition of producer groups for hops.
