28TH MEETING OF THE MANAGEMENT COMMITTEE FOR THE COMMON ORGANISATION OF AGRICULTURAL MARKETS (HORIZONTAL QUESTIONS) OF 11 JULY 2008

Chair: Ms SIRACUSA

23 delegations were present; Greece, Cyprus, Hungary and Malta were absent.

1. Working document: Draft Commission Regulation laying down common rules for the granting of an aid for private storage for certain agricultural products:

Currently, the possibility of granting aid for private storage is laid down in the Council Regulations on the common organisation of the markets in certain products. These regulations are replaced by Council Regulation (EC) 1234/2007.

In order to simplify and improve the effectiveness of the management and control mechanisms, common rules should be laid down for the implementation of the private storage aid scheme.
