Fruit and Vegetables

- 1.1 Draft Commission Regulation (EC) No /2008 amending Regulation (EC) No 1580/2007 of 21 December 2007 laying down implementing rules of Council Regulations (EC) No 2200/96, (EC) No 2201/96 and (EC) No 1182/2007 in the fruit and vegetable sector.

Discussion of draft Commission proposal concerning Articles 33, 36, 49, 52, 60, 63 and 120 and Annexes 8 and 13. A revised text was presented to the meeting. Following comments by a number of delegates the Commission proposed certain modifications. Once checked and, if necessary, amended by the legal service the draft will be voted in a future Management Committee, with the aim of publishing the Regulation before the end of the year.
