

**SUMMARY RECORD OF THE 760th MEETING OF THE MANAGEMENT
COMMITTEE
FOR POULTRY MEAT AND EGGS ON 17th MAY 2006**

President: Russell MILDON

All delegations were present, except Luxemburg, absent but represented by Belgium.

Taking into account the signature of the Accession Treaty on 25 May 2005, one observer per acceding state is invited to attend this committee for the agenda items marked with an asterisk (*).

The observers of Bulgaria and Romania were present.

- (1) ***Market situation for poultry meat and eggs: information on production, prices and trade communicated by the Member States and the Commission.
Situation regarding Avian Influenza.**

Information on the market situation.

- (2) ***Exchange of views and opinion on a draft Commission Regulation fixing the export refunds for the egg sector.**

Quarterly fixation: Amounts remain unchanged.

Vote: Favourable opinion (in favour: 314 (24 MS); abstention: 7 (1 MS)).

- (3) ***Exchange of views and opinion on a draft Commission Regulation fixing the export refunds for the poultry meat sector.**

Increase of export refunds for whole broilers from 48 € to 53 €/100 kg and for chicken cuts from 28 € to 33 €/100 kg.

Vote: Favourable opinion (in favour : 301 (23 MS); against : 7 (1 MS); abstention : 13 (1 MS)).

- (4) ***Exchange of views and opinion on a draft Commission Regulation fixing the rates for refunds applicable to eggs and eggs yolks exported as goods not listed in Annex I of the Treaty.**

Quarterly fixation: Amounts remain unchanged.

Vote: Favourable opinion (in favour: 314 (24 MS); abstention: 7 (1 MS)).

- (5) ***Exchange of views and opinion on a draft Commission regulation fixing the representative prices in the egg, albumins and poultry meat sector.**

New representative prices have been fixed on the basis of recent import information.

Vote: Favourable opinion (in favour: 321 (25 MS); against: 0 (0 MS); abstention 0 (0 MS); absent & not represented: 0 (0 MS)).

(6) ***Exchange of views on exceptional market support measures in the poultry meat sector.**

Oral report by the Commission and discussion with Member States. The Commission encouraged concerned Member States to send their official request before 24 May 2006. Possible vote of the regulation in the next Management Committee on 21 June 2006.

(7) ***Exchange of view and possible opinion on a draft Commission decision amending the honey programme for Portugal.**

Vote: Favourable opinion (in favour: 321 (25 MS); against: 0 (0 MS); abstention 0 (0 MS); absent & not represented: 0 (0 MS).

(8) ***Exchange of views and possible opinion on a draft Commission decision amending the honey programme for Denmark.**

Vote: Favourable opinion (in favour: 321 (25 MS); against: 0 (0 MS); abstention 0 (0 MS); absent & not represented: 0 (0 MS).

(9) ***Exchange of views on three draft Commission regulations on import quotas (two regulations amending respectively regulations 1431/94 and 1251/96 and a new regulation implementing the Agreement between the European Community and the United States of America on tariff quotas for poultrymeat).**

First exchange of views; to be continued.

- Export problems with Russia.
