The projects are presently not geared to the larger challenges of big individual buildings / sites, not for urban and village development, not to the larger cultural landscape (including buildings and man made elements). If this cannot be done then specific funding should be put up here. Another element is the badly needed relations between the classic freetrade promotional activities of the EU and the problems that this creates for the maintenance and conservation of not only heritage buildings but the larges population of historic buildings. Something needs to done here - but probably not only as part of the Culture programme.</p>
