



## Weekly meeting of the Barroso Commission: round table

The Members of the European Commission gathered on 4 March 2009 in Brussels for their weekly meeting, with one main issue on the agenda: to put forward its proposals for the Spring Council of EU Heads of State or Government. The Commissioners were expected to analyse how the EU recovery plan is working and what else can be done to face the economic and financial crisis. They also studied the proposals of the High Level Group on Cross-border Financial Supervision chaired by Jacques de Larosière, that stressed the need of improving regulation and supervision of financial institutions.
