Question Time with Commissioners Geoghegan-Quinn, Kroes and Vassiliou focused today in the European Parliament on research and innovation, particularly under the EU's "Horizon 2020" research programme for 2014-2020. Horizon 2020 aims to make the EU a world-leading economy. In order to achieve this goal, EU budget should reflect this goal, said the Industry Committee in its November vote on the programme. The Commission proposed an €80 billion budget for the programme, but MEPs are pressing for more. The proposed support for research and innovation under Horizon 2020



will: strengthen the EU's position in science with a dedicated budget of € 24 598 million. This is intended to provide a boost to top-level research in Europe, including an increase in funding of 77% for the very successful European Research Council (ERC7). Horizon 2020 should provide major simplification through a single set of rules. It will combine all research and innovation funding currently provided through the Framework Programmes for Research and Technical Development, the innovation related activities of the Competitiveness and Innovation Framework Programme (CIP5) and the European Institute of Innovation and Technology (EIT6).

Each one of them said they would like to see themselves at home, and I asked does this mean your own Member State and they say no, they meant the European union. And I said : what's preventing them to do so ? And they said : because everything is unclear, our career profile is unclear, mobility is difficult, taking a funding grant with your cross-border is impossible. So we need you to put in place the kind of landscapes that is necessary to encourage us to come back. and that's what Horizon 2020 is doing, that's what it is about, that's what the European Research area is all about, it's creating that level playing field so that people think it's a good place to do business.</p>

And we are very conscious of this and always have been and we have ethical responses within the Directorate General in relation to this all area, because we are conscious that the funding, the money that comes from the European taxpayers, needs to be used in research and innovation that add to the wellbeing of the European Union, that provide the kind of growth, innovation and sustainability that is required within the European Union.
