



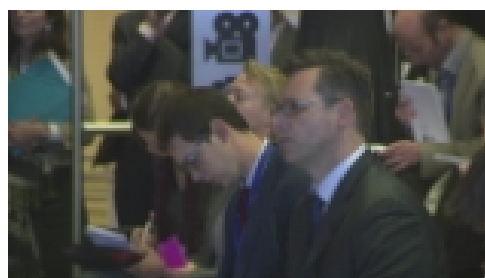

On 30 September 2013, Michel Barnier, Member of the EC in charge of Internal Market and Services, Benoît Battistelli, President of the European Patent Office (EPO), and António Campinos, President of the OHIM, gave a press briefing where they presented a study entitled “Intellectual Property Rights intensive industries: contribution to economic performance and employment in Europe”. This study measures the importance of Intellectual Property rights in the EU economy.

How achieve these results? The Americans did this study a couple of years ago. Saying that they started to use the same methodology, they try to do comparisons with the American study, the idea is not that simple. The idea is basically to build a bridge between a data basis of patents, the trade marks, designs and models and to look at economic performance per economic sectors and when you are above the average, you can consider yourself as an intensive user of intellectual property and if you are below average, you are not an intensive user of intellectual property.
