#### THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Decision No 1639/2006/EC of the European Parliament and of the Council of 24 October 2006, establishing a Competitiveness and Innovation Framework Programme 2007-2013<sup>1</sup>, and in particular to Article 24 thereof,

Having regard to Commission Decision C(2012) 9249 of 13 December 2012 establishing support measures associated with the 2013 annual work programme for the Entrepreneurship and Innovation Programme (hereinafter referred to as EIP),

Having regard to Regulation (EU, Euratom) No 966/2012 of the European Parliament and of the Council of 25 October 2012 on the financial rules applicable to the general budget of the Union<sup>2</sup> and in particular to Article 84 thereof,

#### Whereas:

- (1) The Commission has adopted Decision C(2012) 9249 of 13 December 2012 establishing support measures associated with the 2013 annual work programme for EIP.
- (2) This decision constitutes a financing decision pursuant to Article 84 of Regulation (EU, Euratom) No 966/2012.
- (3) It has become necessary to amend the support measures associated with the 2013 annual work programme for the EIP as described in Decision C(2012) 9249.

## HAS DECIDED AS FOLLOWS:

#### Sole Article

Commission Decision C(2012) 9249 is amended as follows:

1. The Annex to Decision C(2012) 9249 is replaced by the Annex to this Decision.
