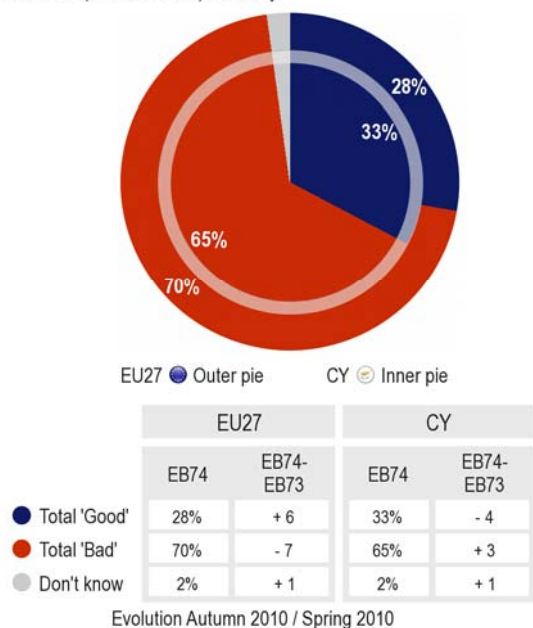


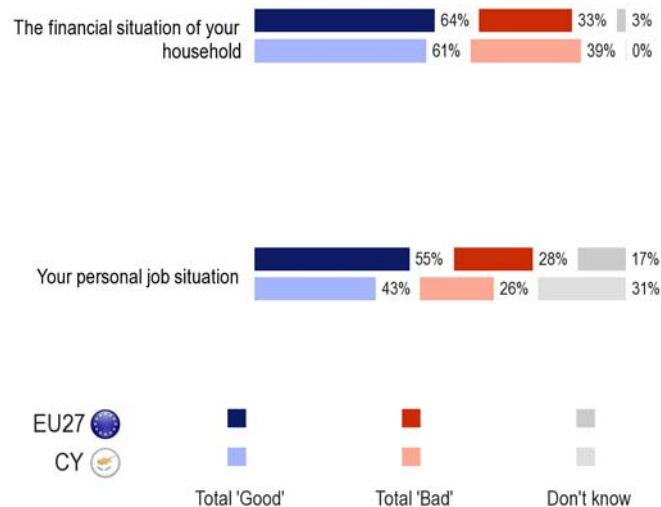

QA4a.1. How would you judge the current situation in each of the following?

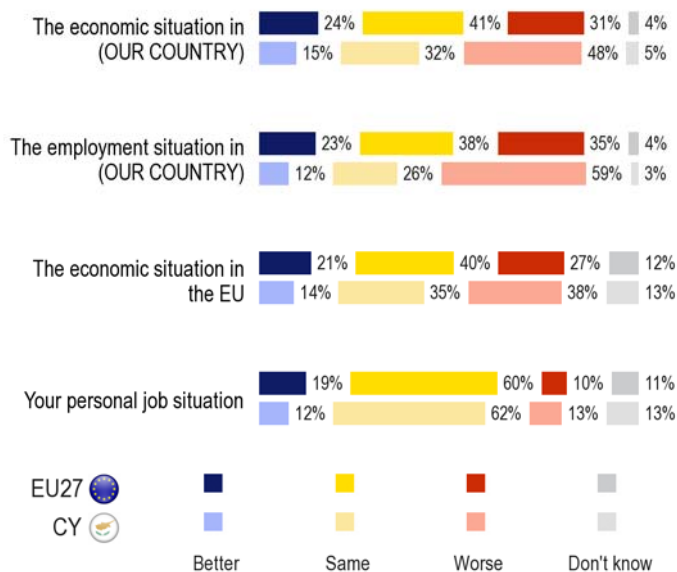
The situation of the (NATIONALITY) economy

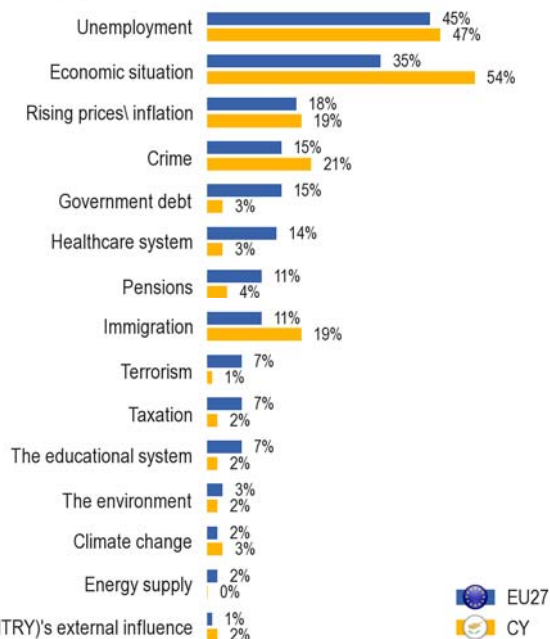

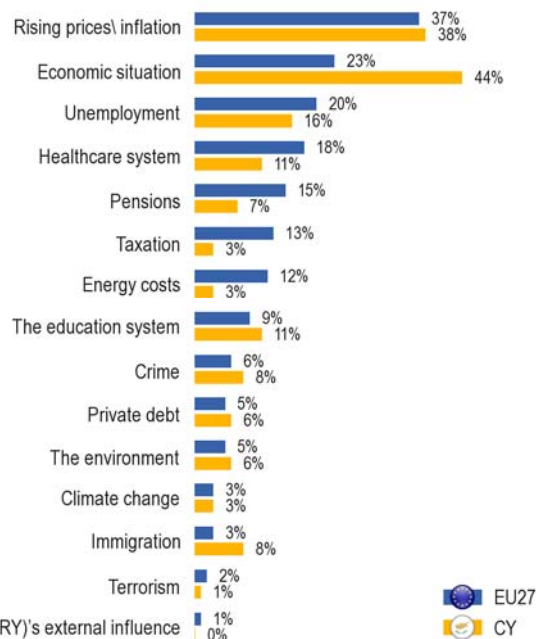

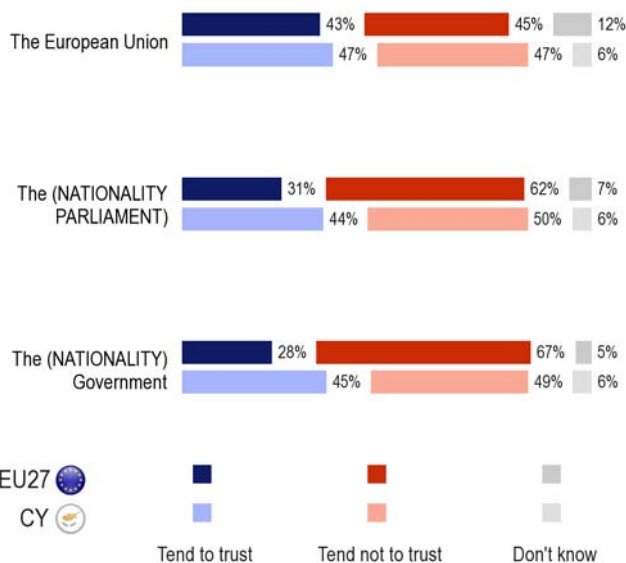
QA6a2. What do you think are the two most important issues facing (OUR COUNTRY) at the moment?

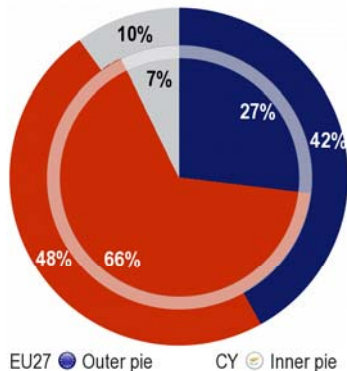

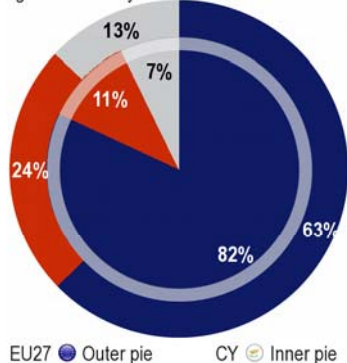

The European Union has sufficient power and tools to defend the economic interests of Europe in the global economy

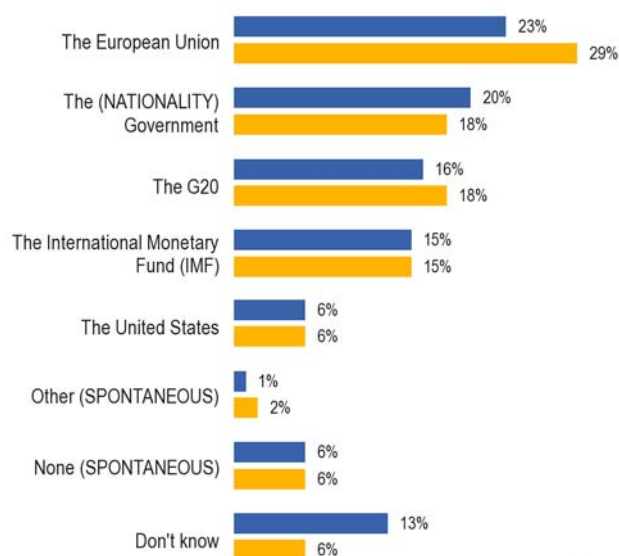

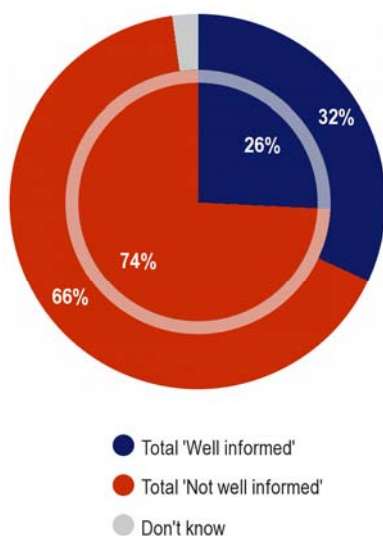

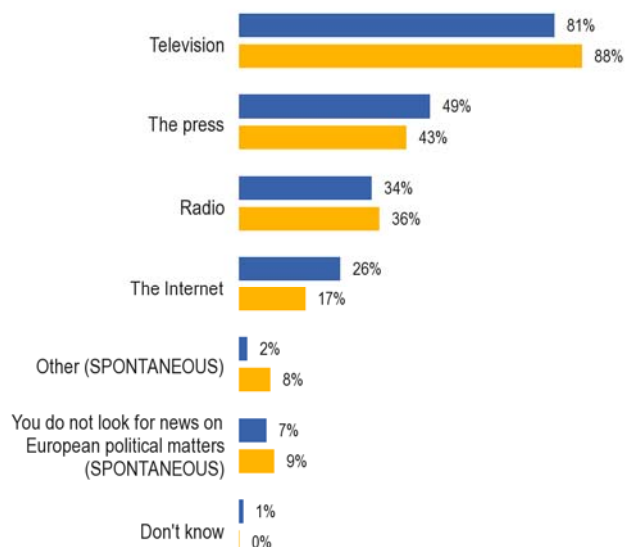
QD2. And overall, to what extent do you think that you are well informed or not about European matters?
