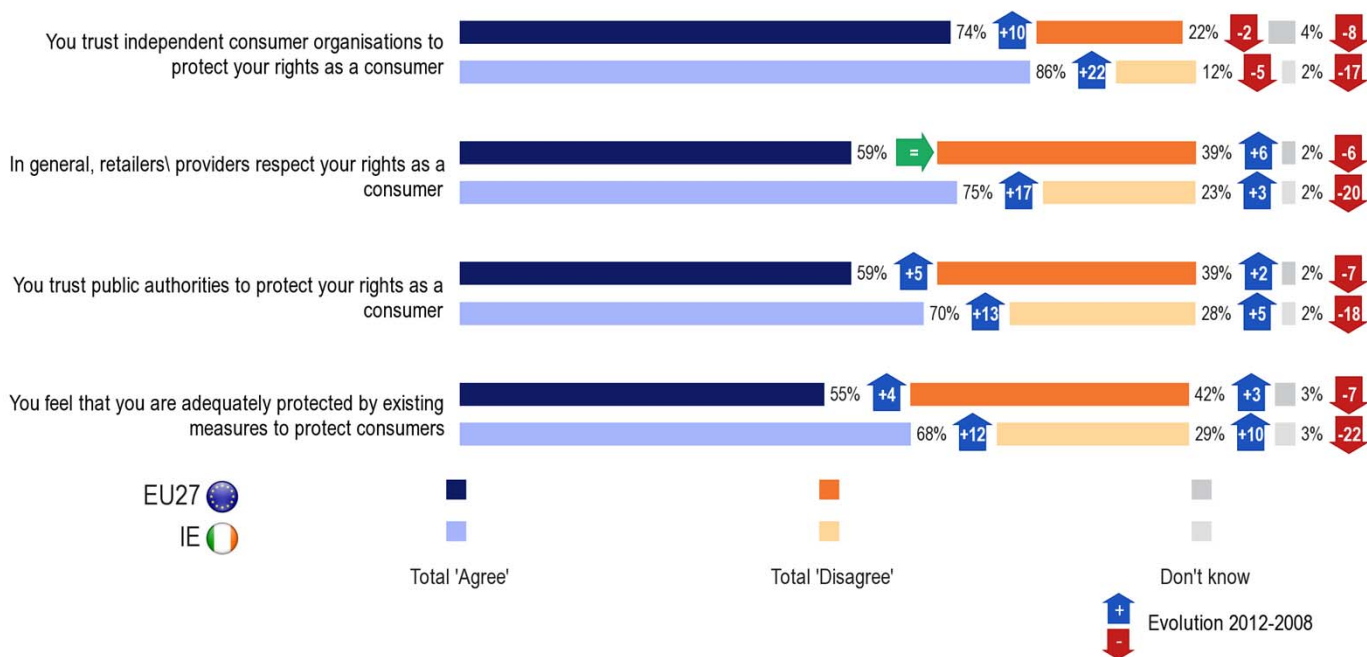

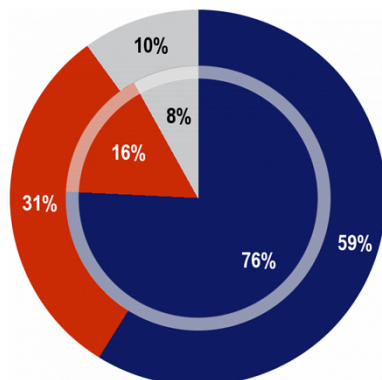

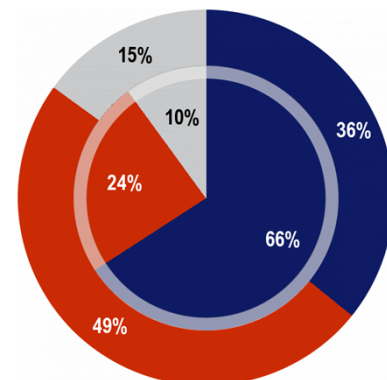
You feel confident purchasing goods or services via the Internet from retailers/providers in (OUR COUNTRY)
