Subject: State aid No. SA.37668 (2013/N) – Portugal

Prolongation of the approved scheme N 421/2006 (Zona Franca da

Madeira) until and including 30 June 2014

1. PROCEDURE

- (1) On 28 June 2013 the Commission adopted the Guidelines on Regional State Aid for 2014-2020¹ (hereinafter "RAG 2014-20"), in which it extended the period of application of the Guidelines on National Regional Aid 2007-2013² (hereinafter "RAG 2007-13") until 30 June 2014 (paragraph 186). The Commission invited Member States to notify the prolongation of their regional aid maps approved for 2007-13 and the prolongation of the approved aid schemes under RAG 2007-13 for the period from 1 January 2014 to 30 June 2014 (paragraph 187).
- (2) By its decision of 30 October 2013 the Commission approved the extension of application of the regional aid map for Portugal for 2007-2013 (SA.37471)³ until and including 30 June 2014.

(3) On 7 November 2013 Portugal notified by electronic notification the prolongation of the approved aid scheme N 421/2006 (Zona Franca da Madeira) by using the simplified notification procedure laid down in Article 4 of the Implementing Regulation⁴ (hereinafter Implementing Regulation).

2. DESCRIPTION OF THE AID SCHEME AND THE NOTIFIED AMENDMENT

- (4) The aid scheme N 421/2006 has been declared compatible with the internal market pursuant to Article 107 of the TFEU⁵ by Commission decision of 27 June 2007 (SA.21259)⁶ and modified by Commission decision of 2 July 2013 (SA.34160)⁷. With the present notification Portugal seeks to extend the period of application of the aid scheme N 421/2006, as modified, until and including 30 June 2014.
- (5) Portugal confirmed that all other conditions and commitments contained in the Commission decision approving the State aid scheme N 421/2006, as modified, remain unchanged.
- (6) Portugal confirmed that the notification does not contain business secrets. Therefore, the full text of the letter will be published on the Internet site http://ec.europa.eu/competition/elojade/isef/index.cfm.

3. ASSESSMENT

- (7) The Commission assesses the notified amendment in accordance with Article 4 of the Implementing Regulation, on the basis of the RAG 2007-13 and of paragraphs 186 and 187 of the RAG 2014-20.
- (8) The Commission notes that the notification concerns the prolongation of the authorised aid scheme N 421/2006, as modified, until and including 30 June 2014, which is in conformity with paragraph 187 of the RAG 2014-2020. As the prolongation of this authorised aid scheme is limited to six months (i.e. from 1 January 2014 until 30 June 2014), it is significantly shorter than the six year period provided for in Article 4(2)(b) of the Implementing Regulation.
- (9) The Commission is therefore of the view that the prolongation of the aid scheme N 421/2006, as modified, until and including 30 June 2014 is compatible with the internal market pursuant to Article 107 of the Treaty on the Functioning of the European Union.
