**SUBJECT: STATE AID SA.38182 (2014/N) – FRANCE
REGIONAL AID MAP 2014-2020**

Sir,

1. PROCEDURE

- (1) On 28 June 2013 the Commission adopted the Guidelines on Regional State Aid for 2014-2020¹ (hereinafter "RAG"). Pursuant to paragraph 178 of the RAG, each Member State should notify to the Commission, following the procedure of Article 108(3) of the Treaty on the Functioning of the European Union, a single regional aid map applicable from 1 July 2014 to 31 December 2020. In accordance with paragraph 179 of the RAG, the approved regional aid map is to be published in the *Official Journal of the European Union*, and will constitute an integral part of the RAG.
- (2) By letter dated 16 January 2014, registered at the Commission on 16 January 2014 (2014/004765), the French authorities duly notified a proposal for the regional aid map of France for the period from 1 July 2014 to 31 December 2020.
- (3) On 14 February 2014 the Commission requested additional information (2014/016613), which was provided by the French authorities on 11 March 2014 (2014/027539), on 25 March 2014 (2014/033926) and on 2 April 2014 (2014/037495).

2. DESCRIPTION OF THE NOTIFIED REGIONAL AID MAP

- (4) In their notification, the French authorities propose a list of regions with a total population of 15,874,136 inhabitants for eligibility for regional aid on the basis of the derogations provided for in Article 107(3)(a) and (c) of the TFEU for the period from 1 July 2014 to 31 December 2020. The notified list includes 'a' regions and non-predefined 'c' areas. The French authorities also propose to set aside a population reserve of 233,757 inhabitants.

2.1 Article 107(3)(a) regions

- (5) In their notification, the French authorities propose five NUTS 2 regions for eligibility on the basis of the derogation provided for in Article 107(3)(a) TFEU for the period from 1 July 2014 to 31 December 2020. Those five areas are presented in table 1 below. The table also presents the maximum aid intensity applicable to initial investment by large enterprises proposed for each region.

2.2 Non-predefined Article 107(3)(c) areas

- (6) In their notification, the French authorities also propose to designate several non-predefined areas as eligible for regional aid under Article 107(3)(c) TFEU for the period from 1 July 2014 to 31 December 2020. The non-predefined 'c' areas are proposed in accordance with different criteria set out in paragraph 168 of the RAG. The tables 2 to 4 below present the list of non-predefined 'c' areas proposed. The French authorities propose a maximum aid intensity of 10% for aid granted to large enterprises in all of those areas. The tables also show the total population of each zone proposed². A more detailed description of the composition of each non-predefined 'c' area is presented in Annex.

2.2.1 Non-predefined 'c' areas in application of Criterion 1 of paragraph 168 of the RAG

- (7) Table 2 below presents the list of proposed non-predefined areas, along with the maximum aid intensity proposed for each region, for which France submits that the conditions of Criterion 1 of paragraph 168 of the RAG are fulfilled.

2.3 Population reserve

- (10) In their notification, the French authorities propose to establish a reserve of national population coverage in accordance with paragraph 180 of the RAG. According to the French authorities the population reserve is equivalent to 0.36% of the national population (233,757 inhabitants), based on the most recent data on the resident population of France as published by the national statistical office³.

2.4 Maximum aid intensities for SMEs

- (11) In accordance with paragraph 177 of the RAG, the French authorities propose that maximum aid intensities applicable to large enterprises can be increased by up to 20 percentage points for small enterprises or by up to 10 percentage points for medium-sized enterprises. However, the increased maximum aid intensities for SMEs⁴ will not apply to aid awarded for large investment projects with eligible expenditure above EUR 50 million.

3. ASSESSMENT

- (12) In accordance with Annex I of the RAG, five NUTS 2 regions of France are eligible for regional aid on the basis of the derogation provided for in Article 107(3)(a) TFEU for the period from 1 July 2014 to 31 December 2020. In addition, Annex I of the RAG provides that France has the possibility to designate areas containing 21.24% of its national population as non-predefined areas eligible for regional aid under the derogation in Article 107(3)(c) TFEU for the period from 1 July 2014 to 31 December 2020.
- (13) As explained in more detail below, the regional aid map notified by France respects all the conditions set out in the RAG.

3.1 Article 107(3)(a) regions

- (14) The regions proposed by France for eligibility for regional aid under the derogation in Article 107(3)(a) TFEU for the period from 1 July 2014 to 31 December 2020 correspond to those listed in Annex I of the RAG.
- (15) Paragraph 172 of the RAG provides that maximum aid intensities applicable to investment by large enterprises in 'a' regions should not exceed:
- 50% GGE in NUTS 2 regions with a GDP per capita below or equal to 45% of the EU-27 average,

- 35% GGE in NUTS 2 regions with a GDP per capita between or equal to 45% and 60% of the EU-27 average;
 - 25% GGE in NUTS 2 regions with a GDP per capita above 60% of the EU-27 average.
- (16) In accordance with paragraph 173 of the RAG, the above intensities may be increased by up to 20 percentage points in outermost regions that have a GDP per capita below or equal to 75% of the EU-27 average or by up to 10 percentage points in other outermost regions.
- (17) The aid intensities proposed by France respect these provisions, as can be seen from the data concerning the GDP per capita of each region indicated in Table 5.

3.2 Proposed list of non-predefined Article 107(3)(c) areas

- (18) In accordance with Annex I of the RAG, France can designate areas with a population of up to 21.24% of the total national population as non-predefined 'c' areas. Compliance with the population coverage allowed will be determined on the basis of the most recent data of total resident population of France as published by the national statistical office.
- (19) The non-predefined 'c' areas proposed by France have a total population of 13 543 051 inhabitants, which represents 20.88% of the total national population. That percentage does not exceed the maximum population coverage allocated to France in Annex I of the RAG.
- (20) The difference between the maximum population that France can designate as non-predefined 'c' areas (13,776,808 inhabitants, i.e. 21.24% of the total national population) and the 'c' areas effectively proposed by France (13,543,051 inhabitants, i.e. 20.88% of the total national population) amounts to 233,757 inhabitants (i.e. 0.36% of the total national population). France proposes to constitute a population reserve of this amount.
- (21) In accordance with paragraph 170 of the RAG, compliance with the population coverage has been determined on the basis of the most recent data on the total resident population of the areas concerned, as published by France's national statistical office.
- (22) The statistics on unemployment used in this section are the average unemployment rates for the period 2009-2011 (i.e. the last three years for which such data are

available), as published by France's national statistical office. This is in line with the requirement set out in footnote 68 of the RAG.

- (23) In cases where non-predefined 'c' areas are proposed that are not defined as whole NUTS 3 regions or islands, paragraph 169 of the RAG provides that the notion of contiguous areas normally refers to whole LAU 2 areas or to a group of whole LAU 2 areas which share an administrative border with another LAU 2 area in the group. In the case of France, the LAU 2 level refers to the municipality level. According to footnote 74 of the RAG, the Member State may nevertheless designate parts of an LAU 2 area (or LAU 1 area), provided that two cumulative conditions are met. First, the population of the LAU area concerned exceeds the minimum population required for contiguous areas under Criterion 1 or 5 set out in paragraph 168 of the RAG. Second, the population of the parts of that LAU area is at least 50% of the minimum population required under the applicable criterion.

3.2.1 Non-predefined 'c' areas in application of Criterion 1 of paragraph 168 of the RAG

- (24) According to paragraph 168 of the RAG, a Member State may designate as non-predefined 'c' areas under Criterion 1 contiguous areas of at least 100,000 inhabitants located in NUTS 2 or NUTS 3 regions that have a GDP per capita below or equal to the EU-27 average or an unemployment rate above or equal to 115 of the national average.
- (25) Each of the non-predefined 'c' areas proposed by France under Criterion 1 is a contiguous zone that satisfies the minimum population size condition (at least 100,000 inhabitants) and the GDP condition (see table 6 below). Moreover, the Commission has been satisfied that each 'c' area proposed under Criterion 1 consists of LAU 2 areas or parts of LAU 1 areas as required in footnote 74 of the RAG.

3.2.2 Non-predefined 'c' areas in application of Criterion 3 of paragraph 168 of the RAG

- (26) According to paragraph 168 of the RAG, a Member State may designate as non-predefined 'c' areas under Criterion 3 islands or contiguous areas characterised by similar geographical isolation with a GDP per capita below or equal to the EU-27 average or an unemployment rate above or equal to 115 of the national average or less than 5,000 inhabitants.
- (27) France proposed five non-predefined 'c' areas under Criterion 3 which fulfil the conditions of Criterion 3, as indicated below (see table 7).

- (28) The Commission considers that the conditions for eligibility under Criterion 3 are fulfilled for the following reasons:
- The area "Aurillac élargi" fulfils Criterion 3 as it is a geographically isolated mountainous area with a GDP per capita well below the EU-27 average (see table 7 above) and the zone proposed consists of a group of contiguous administrative areas.
 - The area "Château-Chinon" fulfils Criterion 3 as it is a geographically isolated mountainous area with less than 5 000 inhabitants, and the zone proposed consists of a group of contiguous administrative areas.
 - The area "Cheylard" fulfils Criterion 3 as it is a geographically isolated mountainous area with less than 5 000 inhabitants and the zone proposed consists of a group of contiguous administrative areas.
 - The area "Corse" fulfils Criterion 3 as it is an island with a GDP per capita below the EU-27 average.
 - The area "Gap" fulfils Criterion 3 as it is a geographically isolated mountainous area with a GDP per capita below the EU-27 average and the zone proposed consists of a group of contiguous administrative areas.

3.2.3 Non-predefined 'c' areas in application of Criterion 5 of paragraph 168 of RAG

- (29) According to paragraph 168 of the RAG, a Member State may designate as non-predefined 'c' areas under Criterion 5 areas of at least 50 000 inhabitants that are undergoing major structural change or are in serious relative decline provided that

such areas are not located in whole NUTS 3 regions or other contiguous areas that fulfil the condition to be designated as non-predefined areas under Criteria 1 to 4.

- (30) France proposed four non-predefined 'c' areas under Criterion 5, see table 8 below.

- (31) The Commission considers that the non-predefined 'c' areas listed in the previous table fulfil the conditions for eligibility under Criterion 5, and this for the following reasons:
- None of the areas proposed under Criterion 5 is located in NUTS 3 regions or contiguous areas that fulfil the conditions to be designated as non-predefined areas under Criteria 1 to 4;
 - France used the following socioeconomic indicators to select the areas concerned: demographic trends, unemployment rates, evolution of the number of job seekers, evolution of the employed workforce and evolution of median tax revenues. The Commission considers that these indicators are appropriate for measuring relative problems of structural change or decline. Moreover, the available data for those indicators were provided by France's national statistical office.⁵
 - The data for the above indicators show that each of the areas proposed under Criterion 5 scored worse than than the national average for at least one indicator concerned, in conformity with footnote 72 of the RAG.
 - Each of the areas proposed has a total population of at least 50 000 inhabitants and consists of LAU 2 areas or parts of LAU 1 areas as required in footnote 74 of the RAG.

3.2.4 Respect of population ceiling for non-predefined 'c' areas

- (32) Annex I of the RAG sets the population ceiling for non-predefined 'c' areas at a maximum of 21.24% of the total population of France. The non-predefined 'c' areas proposed by France have a total resident population of 13 776 808 inhabitants. This amounts to 21.24% of the total resident population of that Member State and respects therefore the population ceiling set in Annex I of the RAG.

3.2.5 Population reserve

- (33) According to paragraph 180 of the RAG, Member States may decide to establish a reserve of national population coverage consisting of the difference between the population coverage ceiling for non-predefined 'c' areas for that Member State, as allocated by the Commission, and the coverage used for those 'c' areas designated in its regional aid map. The 'c' areas proposed by France correspond to 13,543,051 inhabitants (i.e. 20.88% of the total national population). The population ceiling that France can designate as non-predefined 'c' areas amounts to 13,776,808 inhabitants (i.e. 21.24% of the total national population). France proposes to constitute a population reserve amounting to 233,757 inhabitants (i.e. 0.36% of the total national population). Thus, the population reserve established by the French authorities remains within the population coverage ceiling and complies with paragraph 180 of the RAG.
- (34) The Commission recalls that paragraphs 181 and 182 of the RAG provide that if a Member State decides to use the reserve to add new 'c' areas in its map, this is possible until its national coverage ceiling is reached. For this purpose, a Member State may refer to the most recent socioeconomic data provided by Eurostat or by its national statistical office or other recognised sources. The population of the 'c' areas concerned should be calculated on the basis of the population data used for establishing the initial map. The Member State must notify the Commission each time it intends to use its population reserve to add new 'c' areas prior to putting into effect such amendments.

3.3 Maximum aid intensities proposed for 'c' areas

- (35) In accordance with paragraphs 174 to 176 of the RAG, France proposes to limit the maximum aid intensity in all 'c' areas proposed to 10% GGE. Therefore, the maximum aid intensities for regional investment aid in the 'c' areas notified by France for the period from 1 July 2014 to 31 December 2020 are in line with the maximum aid intensities allowed for under the RAG.

3.4 Increased aid intensities for SMEs

- (36) In accordance with paragraph 177 of the RAG, maximum aid intensities can be increased by 20 percentage points for small enterprises and by up to 10 percentage points for medium-sized enterprises. However, the increased maximum aid intensities for SMEs will not apply to aid awarded for large investment projects with eligible expenditure above EUR 50 million.

3.5 Other commitments made by the French authorities

- (37) The Commission takes note of the following commitments made by the French authorities in the notification:
- (a) The French authorities confirmed that all intentions to grant regional aid will be notified to the Commission in accordance with Article 108(3) TFEU, either as an aid scheme, or as an individual notification, unless a block exemption regulation applies.

- (b) The French authorities confirmed that all regional investment aid will respect the maximum aid intensities of the area concerned as defined in the regional aid map approved by the Commission and published in the *Official Journal of the European Union*.
- (c) The French authorities confirmed that for large investment projects (as defined in paragraph 20(1) of the RAG) the aid ceilings of the area concerned as defined in the regional aid map published by the Commission pursuant to this notification will be adjusted according to the formula in paragraph 20(c) of the RAG.

3.6 Conclusion

- (38) In view of the above, the Commission concludes that the regional aid map for the period from 1 July 2014 to 31 December 2020, as notified by France, is in line with the RAG.
- (39) The Commission recalls that the maximum aid intensities specified in the regional aid map apply only to investments carried out in sectors that fall within the scope of the RAG, as defined in paragraph 10 thereof. In particular, these aid ceilings apply to the processing and marketing of agricultural products only to the extent laid down in the Community guidelines for State aid in the agriculture and forestry sector⁶, or in any guidelines replacing them.

4. DECISION

- (40) The Commission has accordingly decided:
 - to approve the regional aid map of France for the period from 1 July 2014 to 31 December 2020 as set out in the Annex, as it fulfils the conditions laid down in the Guidelines on regional State aid for 2014-2020.
 - to publish the regional aid map as presented in the Annex to this decision in the *Official Journal of the European Union*. The full text of this letter in the authentic language will be published on the following Internet site:
