WORKSHOP PROGRAMME

The workshop will deal with two topical issues:

- Recovery of Unlawful State Aid and
- Public Procurement and State Aid.

According to the Courts, recovery is the “logical consequence” of the fact that an aid is unlawful and incompatible with the internal market. Yet, in practice, many difficulties arise when a State has to recover State aid from a recipient. The inherent conflict of interest on the side of the State – budgetary vs. economic policy considerations – may slow down the recovery process, and the recipients are likely to further delay the repayment.

The second topic aims at clarifying the grey areas between public procurement and State aid trying to find a solution for questions such as

- To what extent can a public tender process help to exclude the granting of State aid? What are the requirements?
- What violations of the tender process will lead to an assumption of State aid?
- Can a State conceal the granting of State aid by following public procurement rules?

For both topics, speakers will share their experience from the perspectives of the Commission, a national administration, and private practice and allow an open and lively discussion.
