### 3. PROPOSAL ASSESSMENT

#### 3.1. Administrative info

##### Assessment round 1

- a) Indicative amount: up to EUR 400 000 (subject to the availability of payment appropriations, the amount awarded may be lower than the overall indicative amount or be spread over time. More information will be available upon adoption of the general budget of the European Union for the year 2015).
- b) Description of the humanitarian aid interventions relating to this assessment round: component 2 described in section 3 of the HIP.
- c) Costs will be eligible from 01/01/2015<sup>1</sup>.
- d) The expected initial duration for the Action is up to 24 months.
- e) Preselected partner:  
VOICE is the preselected partner in compliance with Decision ECHO/WWD/BUD/2015/01000, as it is a unique organisation in combining a broad network of European NGOs which work in a significant range of humanitarian areas pertinent to ECHO's activities. VOICE is a European network of non-profit humanitarian organisations:
  - which are a non-profit legal person; and
  - which have their main headquarters in a Member State of the European Union; and
  - with many FPA-partners as active member of the network and as members of the steering board or committee of the network.

- g) Indicative date for receipt of the above requested information: from 15/01/2015 onwards.
