Extreme urgency brought about by events unforeseeable by the contracting authority and in accordance with the strict conditions stated in the Directive.

There is an imperative need to strengthen and increase the international community's humanitarian response to the Ebola virus disease (EVD) outbreak in West Africa: as of early October 2014, 4 000 cases were confirmed, while 4 000 deaths had been attributed to the EVD; in over 1 month the number of cases could increase up to 16 000 cases. In order to support the international humanitarian response to the EVD in Africa, the United States Government's Department of State offers to make the Department of State's phoenix air-contracted aeromedical biological containment system and aircraft available to third parties for medical evacuation, upon conclusion of an agreement to that effect. As it is necessary and appropriate for ECHO to be able to have access to these specific medical evacuation services, recourse must therefore be had to Article 134(1)(c) of the rules of application pursuant to which a contracting authority may use the negotiated procedure without prior publication of a contract notice, in so far as is strictly necessary, where, for reasons of extreme urgency brought about by unforeseeable events not attributable to the contracting authority, it is impossible to comply with the time limits set for the other procedures.
