COMMISSION IMPLEMENTING DECISION

of 16.6.2014

concerning the adoption of the 2014 work programme and the financing for the implementation of the EU Aid Volunteers initiative

THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation No 375/2014 of the European Parliament and the Council establishing for the period 2014-2020 the "EU Aid Volunteers" initiative (COM(2012)514 final) and in particular Article 21(3) thereof,

Having regard to Regulation (EU, Euratom) No 966/2012 of the European Parliament and of the Council of 25 October 2012 on the financial rules applicable to the general budget of the Union²(hereinafter referred to as the 'Financial Regulation'), and in particular Article 84(2) thereof.

Whereas:

- (1) The European Voluntary Humanitarian Aid Corps ('EU Aid Volunteers initiative') established by Regulation No 375/2014/EU (hereinafter referred to as the Regulation), aims to contribute to strengthening the Union's capacity to provide needs-based humanitarian aid aimed at preserving life, preventing and alleviating human suffering and maintaining human dignity and to strengthening the capacity and resilience of vulnerable or disaster-affected communities in third countries, particularly by means of disaster preparedness, disaster risk reduction and by enhancing the link between relief, rehabilitation and development.
- (2) Pursuant to Article 21(2) of the Regulation, financial assistance to ensure implementation of the EU Aid Volunteers initiative may take any of the forms provided by the Financial Regulation, the subject and conditions of which assistance are to be further specified in annual work programmes, as required by Article 21(3) of the Regulation and Article 128 of the Financial Regulation.
- (3) The present work programme identifies the actions that should be eligible for financial assistance in 2014 under the EU Aid Volunteers initiative.
- (4) This Decision should allow for the payment of interest due for late payment on the basis of Article 92 of the Financial Regulation and Article 111(4) of the Commission Delegated Regulation (EU) No 1268/2012 of 29 October 2012 on the rules of application of the Financial Regulation (referred to hereinafter as 'the Rules of Application').
- (5) In order to provide for some degree of flexibility while applying specific actions covered by this Decision, it is necessary to foresee a possibility for the Authorising Officer to introduce non substantial changes on specific actions. Such changes should

- not, however, have a disproportionate impact on the budget line concerned and they should not significantly affect the nature and objectives of the action.
- (6) For the application of this Decision, it is appropriate to define the term 'substantial change' within the meaning of Article 94(4) of the Rules of Application.
- (7) This constitutes a financing Decision within the meaning of Article 84 (2) of the Financial Regulation and Article 94 of the Rules of Application.
- (8) The measures provided for in this Decision are in accordance with the opinion of the Committee established by Article 26 of Regulation No 375/2014/EU.
- (9) The 2014 Annual Work Programme to implement Regulation No 375/2014/EU should therefore be adopted,

HAS DECIDED AS FOLLOWS:

Article 1

The annual work programme for the implementation of the "EU Aid Volunteers initiative" for the year 2014, as set out in the Annex, is hereby adopted.

The annual work programme constitutes a financing decision within the meaning of Article 84 of the Financial Regulation.

Article 2

The maximum contribution for the implementation of the programme for the year 2014 is set at EUR 12 148 000, to be financed from Budget line 23 04 01 (EU Aid Volunteers) of the general budget of the European Union for 2014:

These appropriations may also cover interest due for late payment.

Article 3

Cumulated changes to the allocations to specific actions not exceeding 20 % of the maximum contribution set in Article 2 of this Decision shall not be considered to be substantial within the meaning of Article 94(4) of Delegated Regulation (EU, Euratom) No 1268/2012, where those changes do not significantly affect the nature of the actions and objective of the work programme. The increase of the maximum contribution set in Article 2 of this Decision shall not exceed 20 %.

The Authorising Officer responsible may amend the present decision to introduce nonsubstantial changes in accordance with the principles of sound financial management and proportionality.

The budget amount indicated covers EU Member States' participation as earmarked for 2014. It may be supplemented by contributions from the EEA countries and future acceding, candidate or potential candidate countries as well as partner countries of the European neighbourhood policy which have signed the appropriate agreement with the EU as provided for under Article 23 of the Regulation establishing the European Voluntary Humanitarian Aid Corps ("EU Aid Volunteers initiative").

Introduction

2014 will be the first year of implementation of actions following the adoption of the Regulation 375/2014/EU. Due to the need to adopt implementing and delegated acts foreseen therein, 2014 will be mainly a year of preparatory measures. In the field of needs assessment, capacity building and technical assistance for certification first actions will be launched.

The pilot projects for the EU Aid Volunteers that started in the middle of 2013 will run for the whole of 2014 allowing for a smooth transition to deployment of EU Aid Volunteers under the Regulation as of 2015, the first call for proposals covering deployment of the EU Aid Volunteers under this initiative being planned to be published during the first trimester of 2015.

It is envisaged to delegate certain tasks related to the technical implementation of the initiative to the Executive Agency EACEA. The agency will notably be in charge of managing calls for proposals under action 1, implement the certification process under 2 and manage the call for tender under action 3.

Objectives and priorities of the EU Aid Volunteers initiative in 2014

The **objectives** are to

- Provide technical assistance to prospective sending organisations to prepare for certification.
- Build capacities of prospective hosting organisations from third countries in view of receiving EU Aid Volunteers in the future and to prepare for implementation of EU Aid Volunteers' projects.
- Launch the certification process of sending and hosting organisations.
- Develop the technical environment for all related support measures such as the database, the Network and communication activities.
- Launching an insurance contract that would ensure insurance coverage of EU Aid Volunteers and other participants for the period 2015-2020.

In order to achieve these objectives, the 2014 Work Programme covers 4 strands of actions:

1. Technical assistance and capacity building

Objectives	Strengthening the capacities of sending and hosting organisations intending to participate in the EU Aid Volunteers initiative and to ensure compliance with the standards and procedures regarding candidate volunteers and EU Aid Volunteers.
Expected results	 Capacities of up to 100 sending and hosting organisations are strengthened in the fields of Disaster risk management, preparedness and response as well as linking relief, rehabilitation and development; Volunteer management according to the standards and procedures for the management of the candidate volunteers and the EU Aid Volunteers; Strengthening local volunteering in third countries; Capacities to undergo certification including administrative capacity; Tools and methods of needs assessment at a local level; Building partnerships with a view of joint projects in the context of the EU Aid Volunteers initiative. Communicating the Union's humanitarian aid principles agreed in the European Consensus on Humanitarian Aid and raise awareness levels and visibility of its humanitarian aid.

Sub-section 1b): Capacity building Eligibility criteria

- Projects are designed and implemented by transnational partnerships involving entities from at least three countries participating in the programme belonging to one of the categories mentioned in the Regulation (Article 10(3)(c)) and at least three third countries in which humanitarian aid activities and operations as per Article (3)(d) take place and which belong to one of the categories mentioned under Article 10(4)(c).
- In each project, the project applicants from countries participating in the programme and at least 2 project applicants from third countries in which humanitarian aid activities and operations take place are active in the field of humanitarian aid as defined in article 3 (d) of the Regulation.
- Project applicants from countries participating in the programme must have been active in the field of humanitarian aid for at least 5 years.
- At least one applicant from countries participating in the programme in each project must have been active in the field of volunteer management for at least 5 years,

3. Insurance

Objectives	Ensuring that EU Aid Volunteers, candidate volunteers undertaking apprenticeship placements and participants to the capacity building activities taking place in the European Union are covered by a complete insurance plan specifically designed to protect them during the entire duration of their project, notably as concerns medical and dental care, pregnancy and childbirth, accident, repatriation, life insurance, insurance against permanent disability and third party liability. In order to ensure harmonised coverage of all participants and following the good practice under the European Voluntary Service, the Commission aims at contracting an insurance company covering all volunteers for the full programme period rather than having implementing partners contracting out individually.
Expected results	An insurance contract is signed for the period 2015-2020 covering all EU Aid Volunteers, candidate volunteers undertaking apprenticeship placements and capacity building participants for actions taking part in Europe.
