#### THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to the Decision of the European Parliament and of the Council No  $1313/2013/EU^1$  on a Union Civil Protection Mechanism and in particular Article 25 thereof,

Having regard to Regulation (EU, Euratom) No  $966/2012^2$  of the European Parliament and of the Council of 25 October 2012 on the financial rules applicable to the general budget of the Union and repealing Council Regulation (EC, Euratom) No 1605/2002 (Financial Regulation), and in particular article 84 (2) thereof,

Whereas:

- (1) The Union Civil Protection Mechanism established by Decision No 1313/2013/EU (hereinafter referred to as the Decision), aims to strengthen cooperation between the Union and Member States and facilitate coordination in the field of civil protection in order to improve the effectiveness of systems for preventing, preparing for and responding to natural and man-made disasters.
- (2) Pursuant to Article 25(2) of the Decision, financial assistance under that Decision may take the form of grants, reimbursement of expenses, public procurement or contribution to the trust funds, the subject and conditions of which are to be further specified in annual work programmes, as required by Article 128 of the Financial Regulation and Article 25(3) of the Decision.
- (3) The present work programme identifies the actions that should be eligible for financial assistance in 2014 under the Union Civil Protection Mechanism in the field of prevention, preparedness, and public awareness.
- (4) Pursuant to Article 188 of the Rules of Application<sup>3</sup> and Article 25(3) of the Decision the work programme specifies the objectives, the schedule of the call or calls for proposals, the indicative amount involved, the maximum rate of financial intervention and the results expected from the actions and projects benefiting from financial assistance in the form of grants.

- (5) The work programme also specifies the circumstances in which, under Article 190 (1) (c), and (f) of the Rules of Application, the Commission may award grants without a call for proposals to bodies with a duly substantiated de facto or de jure monopoly or for actions with specific characteristics that require a particular type of body on account of its technical competence, its high degree of specialisation or its administrative power provided that the actions do not fall within the scope of a call for proposals.
- (6) Under Article 92 of the Financial Regulation, creditors paid late are entitled to receive default interest charged to the line from which the principal was paid. It is therefore necessary to foresee that such default interest falls within the scope of this Decision.
- (7) It is appropriate to define the term 'substantial change' within the meaning of Article 94(4) of the Rules of Application for the application of this Decision.
- (8) This Decision constitutes a financing decision within the meaning of Article 84 (2) of the Financial Regulation and Article 94 of the Rules of Application.
- (9) The measures provided for in this Decision are in accordance with the opinion of the Committee established by Article 33(1) of Decision No 1313/2013/EU.
- (10) The 2014 Annual Work Programme to implement Decision No 1313/2013/EU should therefore be adopted,

HAS DECIDED AS FOLLOWS:

### Article 1

The work programme set out in the Annex is hereby adopted as the 2014 Annual Work Programme on the following budget items, for the appropriations amounts proposed by the Commission in its 2014 draft budget:

- Budget item 23 03 01 01- Disaster prevention and preparedness within the Union for the amount of EUR 27 052 000 and
- Budget item 23 03 01 02- Disaster prevention and preparedness in third countries for the amount of EUR 5 326 000

### Article 2

- 1. Pursuant to Article 190(1) (c) of the Rules of Application, the Commission may award grants without a call for proposals to the Member State holding the Presidency of the Council of the European Union to support the exchange of knowledge and experience on specific strategic civil protection issues and to discuss further civil protection actions between participating states.
- 2. Pursuant to Article 190(1) (f) of the Rules of Application, the Commission may award a direct grant without a call for proposal to Member States that have pre-committed their response capacities to the European Emergency Response Capacity for the purposes of certifying these capacities and adapting them to the standards set for European missions.
- 3. Pursuant to Article 190(1) (f) of the Rules of Application, the Commission may award a direct grant without a call for proposals to the Organisation for Economic Co-operation and Development (OECD) which has a high level of

technical expertise in disaster risk-management to support activities linked to the EU disaster prevention strategy, such as the development by the OECD High Level Risk Forum's work on a methodological risk assessment framework and the organising of country peer reviews.

4. Pursuant to Article 190(1) (f) of the Rules of Application, the Commission may award a direct grant without a call for proposals to the UNESCO Intergovernmental Oceanographic Commission which has unique expertise in tsunami warning systems and a legal mandate from UNESCO member states to facilitate the expansion of such systems and coordinate the establishment of such a system for the North East Atlantic, Mediterranean and connected seas.

# Article 3

Cumulated changes incurring an increase of not more than 20 % of the Union's maximum contribution are not considered to be substantial, provided that they do not significantly affect the nature and objectives of the work programme. The Authorising Officer by Delegation may adopt such changes in accordance with the principles of sound financial management.

# Article 4

The appropriations covered by the work programme may be used to pay default interest in accordance with Article 92 of Regulation (EU, Euratom) No 966/2012.

#### **OBJECTIVES OF THE PROGRAMME**

#### INTRODUCTION

The Union Civil Protection Mechanism should protect primarily people, but also the environment and property, including cultural heritage, from all kinds of natural and man-made disasters, including environmental disasters, marine pollution and acute health emergencies, occurring inside or outside the Union. This work programme covers actions that are eligible for financial assistance under the Mechanism in the field of prevention and preparedness in 2014.

In compliance with Article 26 of Decision No 1313/2013/EU synergies and complementarity with other instruments of the Union will be sought as these actions are implemented<sup>4</sup>.

The budget breakdown and actions implemented under direct centralised management can be broken down according the objectives set out in the Decision as follows:

Objectives	Support and complement the efforts of participating states in the field of disaster prevention, focusing on areas where cooperation provides added value. Support the enlargement countries not participating in the Mechanism <sup>5</sup> and the European Neighbourhood Policy countries <sup>6</sup> in the field of disaster prevention and improve their cooperation with the Union Civil Protection Mechanism and its participating states.

# 2.2 EARLY WARNING AND ANALYSIS

Objectives	Contributing to the development of detection and early warning systems in accordance with Article 8c of the Decision.
	Work will continue to focus on closing gaps and enhancing existing systems. In 2014, the focus will be on:
	• further developing the Global Disaster Alert Coordination System (GDACS), establishing new cyclone surge calculation methods, enhancing volcano and flood detection systems and linking GDACS with the best scientific groups;
	• linking flood detection and forecast systems at global level;
	• enhancing the European Floods Awareness System (EFAS) for flash floods, including an indicator covering virtually the whole of Europe

	and ability to provide ERCC with scientific flood analysis;
	• further developing the European Forest Fire Information System (EFFIS) fire danger forecast and fire monitoring platform, including fire severity mapping and fire spread modelling;
	• setting up a pilot Global Fire Information System;
	• further improving the drought system, taking into account relevant climate services.
	Work will start on extending EFAS coverage to Neighbourhood Policy countries and enlargement countries which are not yet EFAS members. In parallel, a technical study will look at the potential for flood early- warning and/or monitoring systems in the Eastern and Southern Neighbourhood countries.
