The objective of the contract is to improve knowledge of civil protection personnel by offering learning experience in host civil protection organisations.

The purpose of this call for tender is to select a contractor able to design, organise, promote, manage, monitor and evaluate the system of exchange of experts in civil protection for a 24-month period. The system should be designed to allow the participation of 450–500 experts during the period covered by the contract, including 50 to 75 experts from eligible third countries.

— a pre-financing payment of 20 % of the contract amount after the entry into force of the contract,

— a second interim payment of 30 % of the contract amount upon acceptance by the European Commission of the 2nd interim report submitted after 16 months,

— the payment of the balance upon acceptance by the Commission of the final report.
