




BUSINESS AND CONSUMER SURVEY RESULTS

In June, after two consecutive months of improved readings, the *Economic Sentiment Indicator* (ESI) remained broadly unchanged in both the euro area (-0.2 points to 104.4) and the EU (+0.1 points to 105.7).¹

Euro area developments

Flat euro-area sentiment resulted from increasing confidence in industry, the sector with the highest weight in the ESI, which offset drops in services and construction and, in particular, retail trade. Consumer confidence remained broadly flat. Amongst the largest euro-area economies, the ESI rose in the Netherlands (+2.1), Germany (+1.6) and Spain (+0.8), while it decreased in Italy (-3.6) and France (-1.7).

Improved **industry confidence** (+0.9) resulted from managers' more optimistic *production expectations* and - to a lesser extent - better assessments of the *current level of overall order books*, which more than outweighed somewhat more critical appraisals of the *stocks of finished products*. Of the questions not included in the confidence indicator the level of *export order books* and, in particular, *past production* were assessed more negatively. Slightly easing **services confidence** (-0.5) was the result of managers' more pessimistic *demand expectations*, which were only partly counterbalanced by modestly improved/virtually unchanged assessments of the *past business situation/past demand*. **Consumer confidence** remained largely flat (-0.3). While less respondents seemed concerned about *future unemployment*, their assessments of the *future general economic situation* and their *savings expectations* deteriorated. Consumers' views on their *future financial situation* remained virtually unchanged. **Retail trade confidence** weakened markedly (-2.5) due to managers' sharply deteriorating assessments of the *present business situation* and the adequacy of the *volume of stocks*, which dominated mild improvements in the *expected business situation*. **Construction confidence** eased (-0.5) as a consequence of managers' more cautious views on the level of *order books* and *employment expectations*. **Financial services confidence** (not included in the ESI) moved broadly sideways. While past developments were viewed more positively (*past business situation, past demand*), *demand expectations* clouded over.

Employment plans were revised upwards in industry and retail trade, but downwards in services and construction. **Selling price expectations** decreased markedly in the services sector while remaining broadly unchanged in retail trade and construction and firming in industry. Consumer price expectations registered a significant increase and are now at heights which were last seen 1 ½ years ago.

EU developments

In line with euro-area developments, the virtually unchanged reading of the ESI in the EU resulted from higher industry confidence, counteracted by deteriorating sentiment in services, construction and retail trade. Same as in the euro area, EU consumer confidence moved sideways. Looking at the largest non-euro area countries, Poland followed the flat trend in sentiment (-0.1), while the UK posted a 1.3 point increase.

Turning to managers' employment expectations, EU developments were in line with those in the euro area. The same also goes for managers' and consumers' price expectations, with the exception of retail trade, where EU figures hint at an increase, rather than flat developments.

¹ The business confidence indices for France were slightly revised compared to the May press release, causing a downward revision of a decimal point of the ESI for the euro area (to 104.6) and the EU (to 105.6). Furthermore, note that the results of the French services survey for the period January 2013 to May 2016 have been slightly revised so as to stabilise the sectoral classification of enterprises participating in the survey.








