

**ADDENDUM N° 1 TO FRAMEWORK CONTRACT

The European Community, represented by the European Commission, for and on behalf of the beneficiary countries

("The Contracting Authority"),

of the one part,

have agreed as follows:

A. The following provisions of the Special Conditions of the Framework Contract EuropeAid/119860/C/SV/multi concluded between the Contracting Authority and the Framework contractor on 8th September 2005 (the "Framework Contract") are hereby replaced as follows:

Article 3 - Contract value

The Framework Contract has no contractual amount or maximum budget. The Specific Contracts, established in euro, may be concluded as either fee-based contracts or global price contracts based in both cases on the fees brackets defined in Annex V. The contractual amount is fixed at the level of each individual assignment and this amount including any addendum to the initial assignment must remain below 200,000 euros.

A revision of prices may take place as from the 16th September 2007. The revision applies to the fees of the global financial offer.

This revision shall be determined by the trend in the consumer price index MUICP published by the Office for Official Publications of the European Communities in the Eurostat monthly bulletin (Theme 2 Economy and Finance, Collection Detailed tables, Money, finance and the euro: Statistics).

Revision shall be calculated in accordance with the following formula:

$$Pr = Po \frac{Ir}{Io}$$

where

Pr = revised price;

Po = price in the original global financial offer;

Io = index for the month corresponding to the final date for submission of tenders;

Ir = index for the month of July 2007.

Article 5 - Period of implementation

The Framework Contract implementation shall end on the 15th of September 2009. However, for Requests for Services sent by this date, the offers can be presented and the subsequent Specific contracts signed normally.

The schedule and the time awarded for the implementation of each individual assignment will be specified in each Specific Contract.

B. In Annex II "Global Terms of Reference" in article 6.5.1 "Experts", the reference to annex 7 is deleted in the following sentence:

"For each assignment, each expert shall have to declare (*see Annex 7*) that: [...]."

All other terms and conditions of the Framework Contract remain unchanged. This addendum shall enter into force on the later date of signature by the Parties.
