THE EUROPEAN COMMISSION,

Having regard to the Treaty on the Functioning of the European Union,

Having regard to Regulation (EU, Euratom) 2018/1046 of the European Parliament and of the Council of 18 July 2018 on the financial rules applicable to the general budget of the Union, amending Regulations (EU) No 1296/2013, (EU) No 1301/2013, (EU) No 1303/2013, (EU) No 1304/2013, (EU) No 1309/2013, (EU) No 1316/2013, (EU) No 223/2014, (EU) No 283/2014, and Decision No 541/2014/EU and repealing Regulation (EU, Euratom) No 966/2012¹, and in particular Article 110 thereof,

Having regard to Regulation (EU) 2021/690 of the European Parliament and of the Council establishing a Programme for single market, competitiveness of enterprises, including small and medium-sized enterprises, the area of plants, food and feed, and European statistics and repealing Regulations (EU) No 99/2013, (EU) No 1287/2013, (EU) No 254/2014, (EU) No 258/2014, (EU) No 652/2014 and (EU) 2017/826,

Whereas:

- (1) In order to ensure the implementation and development of the Single Market Programme under Regulation (EU) 2021/690 of the European Parliament and of the Council, Implementing Decision C(2023) 1119 was adopted for the years 2023-2024.
- (2) The Annexes to Decision C(2023) 1119 need to be amended as regards the implementation of actions under the activities "Operation and development of the internal market of goods and services" (budget line 03.020101), "Improving the competitiveness of enterprises, particularly SMEs, and supporting their access to markets" (budget line 03.0202), "European Standardisation" (budget line 03.020301) and "Producing and disseminating high quality statistics on Europe" (budget line 03.0205).
- (3) Decision C(2023) 1119 should therefore be amended accordingly.
- (4) The measures provided for in Annex II to this Decision, which concern the specific objective referred to in Article 3(2), point (b) of Regulation (EU) 2021/690, improving the competitiveness of enterprises, particularly SMEs, are in accordance with the opinion of the Committee established by Article 21(1) of that Regulation.
