

# Annual growth in labour costs down to 1.1% in euro area

Down to 1.4% in EU28

Hourly labour costs<sup>1</sup> rose by 1.1% in the **euro area**<sup>2</sup> (EA18) and by 1.4% in the **EU28**<sup>2</sup> in the fourth quarter of 2014, compared with the same quarter of the previous year. In the third quarter of 2014<sup>3</sup>, hourly labour costs increased by 1.4% in the **euro area** and by 1.5% in the **EU28**. These figures are published by **Eurostat**, **the statistical office of the European Union**.

The two main components of labour costs are wages & salaries and non-wage costs. In the **euro area**, wages & salaries per hour worked grew by 1.0% and the non-wage component by 1.2%, in the fourth quarter of 2014 compared with the same quarter of the previous year. In the third quarter of 2014, the annual changes were +1.4% for both components. In the **EU28**, hourly wages & salaries rose by 1.4% and the non-wage component by 1.6% for the fourth quarter of 2014. In the third quarter of 2014, annual changes were +1.4% and +1.7% respectively.




### Breakdown by economic activity

In the fourth quarter of 2014 compared with the same quarter of the previous year, hourly labour costs in the **euro area** rose by 1.3% in industry, by 0.7% in construction, by 0.8% in services and by 1.2% in the (mainly) non-business economy. In the **EU28**, labour costs per hour grew by 1.6% in industry, by 0.9% in construction, by 1.3% in services and by 1.4% in the (mainly) non-business economy in the fourth quarter.

### **Member States**

In the fourth quarter of 2014, the highest annual increases in hourly labour costs for the whole economy were registered in **Romania** (+7.9%), **Estonia** (+6.5%), **Latvia** (+6.1%), **Lithuania** (+5.7%) and **Slovakia** (+5.1%). Decreases were recorded in **Portugal** (-8.8%), **Cyprus** (-2.2%), **Croatia** (-0.5%), **Italy** (-0.3%) and **Ireland** (-0.1%).

- 1. The Labour Cost Index is a short-term indicator showing the development of hourly labour costs incurred by employers. It is calculated dividing the labour cost in national currency by the number of hours worked. Therefore, the development of both variables, labour costs and hours worked, affects the evolution of the index.

The quarterly changes in hourly employers' costs are measured for total labour costs and the main components: wages and salaries; and labour costs other than wages and salaries (non-wage costs). Total labour costs (TOT) cover wage and non-wage costs less subsidies. They do not include vocational training costs or other expenditures such as recruitment costs, spending on working clothes, etc.

Wage and salary costs (WAG) include direct remuneration, bonuses, and allowances paid by an employer in cash or in kind to an employee in return for work done, payments to employees saving schemes, payments for days not worked and remuneration in kind such as food, drink, fuel, company cars, etc.

Labour costs other than wages and salaries (OTH - non-wage costs) include the employers' social contributions plus employment taxes regarded as labour costs less subsidies intended to refund part or all of the employer's cost of direct remuneration.

Eurostat publishes Labour Cost Index data for NACE Rev. 2 sections B to S. The aggregate is referred to as "Whole economy" for the sake of simplification, even if agriculture, activities of households as employers and activities of extraterritorial organisations are excluded. 2. Up to 31 December 2014, the euro area (EA18) included Belgium, Germany, Estonia, Ireland, Greece, Spain, France, Italy, Cyprus, Latvia, Luxembourg, Malta, the Netherlands, Austria, Portugal, Slovenia, Slovakia and Finland. From 1 January 2015 the euro area (EA19) also includes Lithuania.

The European Union (EU28) includes Belgium (BE), Bulgaria (BG), the Czech Republic (CZ), Denmark (DK), Germany (DE), Estonia (EE), Ireland (IE), Greece (EL), Spain (ES), France (FR), Croatia (HR), Italy (IT), Cyprus (CY), Latvia (LV), Lithuania (LT), Luxembourg (LU), Hungary (HU), Malta (MT), the Netherlands (NL), Austria (AT), Poland (PL), Portugal (PT), Romania (RO), Slovenia (SI), Slovakia (SK), Finland (FI), Sweden (SE) and the United Kingdom (UK).

As part of Eurostat's guidelines for the dissemination of data when the euro area is enlarged, the aggregate data series commented on in this News Release refer to the official composition in the most recent quarter for which data is available. Thus News Releases with data for quarters up to the fourth quarter of 2014 comment on EA18 series, while Releases with data for the first quarter of 2015 onwards will comment on EA19 series.

3. Compared with News Release 198/2014 of 17 December 2014, annual growth rates for the total economy for the third quarter of 2014 were revised from +1.3% to +1.4% for the EA18 and from +1.4% to +1.5% for the EU28.
