


First estimate for April 2015 **EU28 current account surplus €14.9 bn** €12.3 bn surplus for trade in services

The **EU28**¹ seasonally adjusted external current account² recorded a surplus of \in 14.9 billion in April 2015, compared with a surplus of \in 11.0 bn in March 2015 and a surplus of \in 4.9 bn in April 2014, according to estimates³ from **Eurostat**, the statistical office of the European Union.

In April 2015, compared with March 2015, based on seasonally adjusted data, the surplus of the goods account grew (+ \in 10.8 bn compared with + \in 4.3 bn) and the deficit of the secondary income account fell slightly (- \in 7.6 bn compared with - \in 7.8 bn). The surplus of the services account decreased (+ \in 12.3 bn compared with + \in 14.0 bn) while the surplus of the primary income account moved into deficit (- \in 0.7 bn compared with + \in 0.5 bn).

The 12-month cumulated current account for the period ending in April 2015 recorded a surplus of \in 122.0 billion, compared with \in 115.7 billion for the 12 months to April 2014. The surplus of the goods account grew (+ \in 61.3 bn compared with + \in 36.8 bn) and the surplus of the services account rose slightly (+ \in 151.8 bn compared with + \in 150.8 bn), while the surplus of the primary income account moved into deficit (- \in 11.0 bn compared with + \in 3.1 bn) and the deficit of the secondary income account increased (- \in 80.1 bn compared with - \in 75.0 bn).

- The current account covers all transactions occurring between resident and non-resident entities, and refers to international trade in goods and services, as well as primary and secondary income. - 3. The EU balance of payments estimates for the reference month are based on figures provided by the Member States to Eurostat 44 days after the end of the reference month, and should be considered as provisional. Figures may be subject to revision when data for later months are transmitted by the Member States.
- 4. In line with the agreed allocation of responsibility, the European Central Bank (ECB) (<u>www.ecb.int</u>, section statistics/statistical press releases) is in charge of compiling and disseminating monthly and quarterly balance of payments and quarterly international investment position statistics for the euro area, whereas the European Commission (Eurostat) focuses on monthly, quarterly and annual aggregates of the EU. The aggregates for the euro area and the EU are compiled consistently on the basis of Member States' transactions with residents of countries outside the euro area and the European Union respectively.
