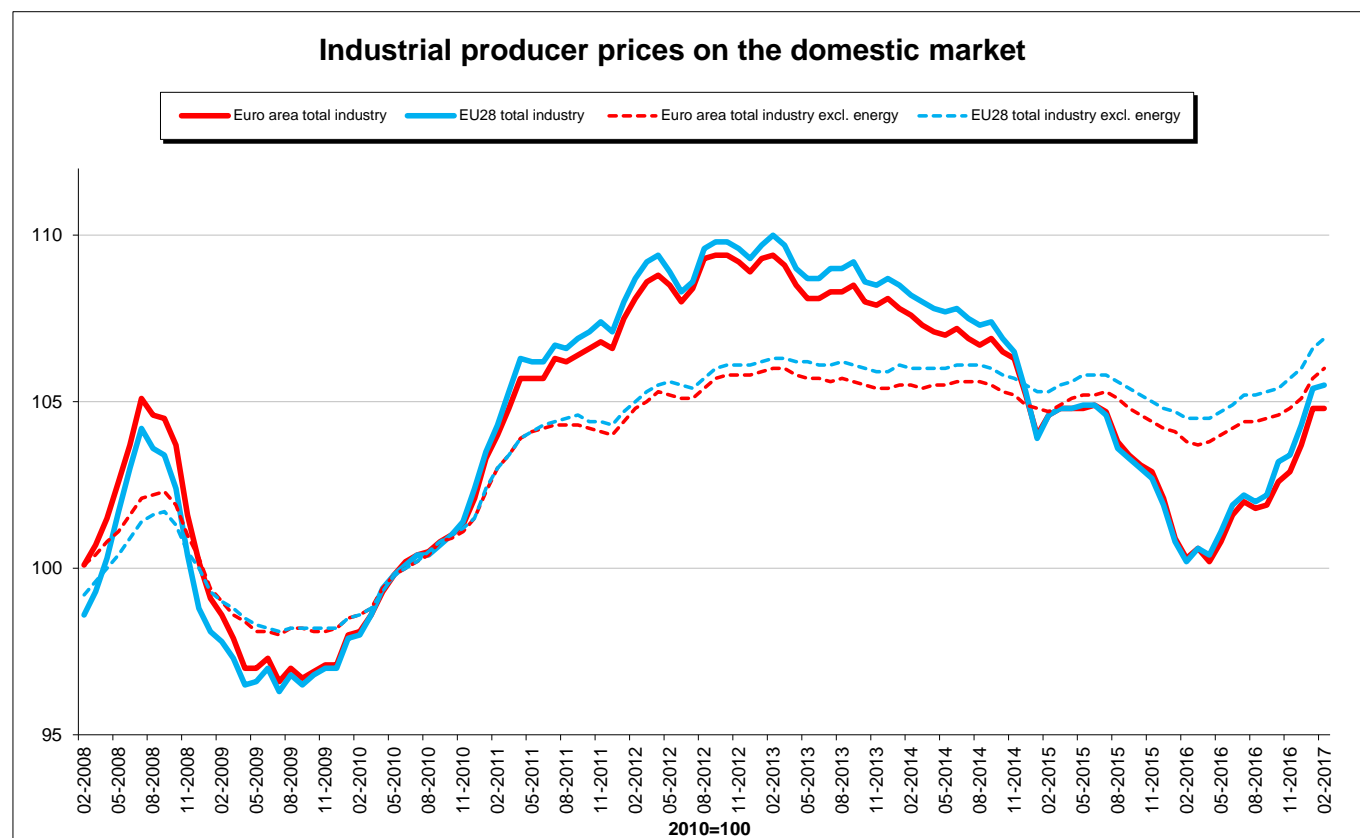
February 2017 compared with January 2017

Industrial producer prices stable in euro area

Up by 0.1% in EU28

In February 2017, compared with January 2017, industrial producer prices remained stable in the **euro area** (EA19), while they rose by 0.1% in the **EU28**, according to estimates from **Eurostat, the statistical office of the European Union**. In January 2017 prices increased by 1.1% in both zones.

In February 2017, compared with February 2016, industrial producer prices rose by 4.5% in the **euro area** and by 5.3% in the **EU28**.



Monthly comparison by main industrial grouping and by Member State

Industrial producer prices in total industry remained stable in the **euro area** in February 2017, compared with January 2017, due to rises of 0.6% for intermediate goods, of 0.2% for non-durable consumer goods and of 0.1% for both capital goods and durable consumer goods, while prices fell by 1.1% in the energy sector. Prices in total industry excluding energy rose by 0.3%.

In the **EU28**, the 0.1% increase is due to rises of 0.6% for intermediate goods, of 0.2% for non-durable consumer goods and of 0.1% for both capital goods and durable consumer goods, while prices fell by 0.7% in the energy sector. Prices in total industry excluding energy rose by 0.3%.

The highest increases in industrial producer prices were observed in **Greece** (+1.3%), **Ireland** (+0.8%) and **Denmark** (+0.7%), and the largest decreases in **Portugal** (-1.5%), **Spain** (-1.4%) and **Luxembourg** (-0.6%).

Annual comparison by main industrial grouping and by Member State

The 4.5% increase in industrial producer prices in total industry in the **euro area** in February 2017, compared with February 2016, is due to rises of 11.4% in the energy sector, of 3.3% for intermediate goods, of 1.9% for non-durable consumer goods, of 0.8% for capital goods and of 0.7% for durable consumer goods. Prices in total industry excluding energy rose by 2.1%.

In the **EU28**, the 5.3% price increase is due to rises of 15.7% in the energy sector, of 3.3% for intermediate goods, of 2.0% for non-durable consumer goods, of 1.1% for capital goods and of 0.9% for durable consumer goods. Prices in total industry excluding energy rose by 2.3%.

The largest increases in industrial producer prices were recorded in **Belgium** (+14.8%), the **Netherlands** (+11.0%) and the **United Kingdom** (+10.3%), while a decrease was observed in **Luxembourg** (-3.1%).

Geographical information

The **euro area** (EA19) includes Belgium, Germany, Estonia, Ireland, Greece, Spain, France, Italy, Cyprus, Latvia, Lithuania, Luxembourg, Malta, the Netherlands, Austria, Portugal, Slovenia, Slovakia and Finland.

The **European Union** (EU28) includes Belgium, Bulgaria, the Czech Republic, Denmark, Germany, Estonia, Ireland, Greece, Spain, France, Croatia, Italy, Cyprus, Latvia, Lithuania, Luxembourg, Hungary, Malta, the Netherlands, Austria, Poland, Portugal, Romania, Slovenia, Slovakia, Finland, Sweden and the United Kingdom.

Methods and definitions

The **index of producer prices** shows (in the national currency of the country concerned) changes in the ex-works sale prices of all products sold on the domestic market, excluding imports. Euro area and EU indices refer to overall weighted price changes. The figures are not calendar day or seasonally adjusted.

Total industry covers NACE rev.2 sections B to D + E36.

Revisions and timetable

Compared with data issued in the News Release 35/2017 of 2 March 2017, the monthly percentage change for January 2017 has been revised from +0.7% to +1.1% in the euro area and from +0.8% to +1.1% in the EU28. The annual percentage change has been revised from +3.5% to +3.9 in the euro area and from +4.3% to +4.6% in the EU28.
