

# Statistical References Achievements of user support and on Eurostat's website

Dear reader,

For nearly three years now Eurostat has offered its products and services free of charge and easily accessible on its website in accordance with the free dissemination strategy. From the beginning, the user support helped to put this policy into practice, and over the years both the website and user support have undergone a number of modifications.

The user friendliness of website functionalities has been improved considerably taking into account the observations and recommendations of the users and the findings of a benchmarking exercise. Among other amendments, the number of extractable cells was increased considerably. A new feature for the predefined tables, called TGM (tables, graphs and maps) has been implemented in June 2007. Further projects to re-enforce the usability are in the pipeline, including the improvement of the search functionalities.

The three-level support helps users to find data, methodology and publications and has also been subject to several improvements.

On the level of online help, the content of the website was amended. To ease the troubleshooting for the most common problems, the number of FAQs were increased and they were structured in relevant areas. Efforts have been made to improve the methodology and documentation.

To provide a fast and efficient service in nearly all European languages, Eurostat collaborates with the national support centres for the treatment of user requests. Currently, 23 countries participate in the programme, providing support in 21 languages.

To improve our service, cooperation between these national centres and Eurostat is fostered by providing information, quality controls and training on a regular basis.

The national institutes report on their activities and provide user feedback which is taken into consideration for further improvements.

The amendments led to a higher level of user satisfaction in particular concerning the technological aspects for which a decrease of requests could be observed. The approach to provide more sophisticated tools to find and download data and publications has been successful and accepted by the users.

Efforts to improve our website and the user support will continue, and we will keep you informed about Eurostat's activities in the upcoming issue of *Statistical references*.

# In The Spotlight

There are very few aspects of daily life which are not in one way or another accompanied by the use of energy: for example, making a cup of tea or coffee for breakfast, the journey to school or work, using a computer in the workplace, listening to music at home or heating water for a shower, all make use of energy in a variety of forms, either as power or heat. The evolution of the EU is closely linked to energy preoccupations of the Member States as demonstrated by the early ECSC (European Coal and Steel Community) and Euratom Treaties. In those days of cheap imported oil, Member States' efforts concentrated on the peaceful use and promotion of nuclear energy as well as on coal, along with the primary user of this commodity, the steel industry. The oil price shocks in the early seventies and eighties demonstrated the vulnerability of the Union and its Member States as regards imported oil (in particular from the Middle East).

As a result of this, the Member States and the Union promoted numerous policies and measures to diversify their fuel mix and decouple economic growth from energy demand in an attempt to curb oil dependency. In the nineties, a period of relatively low oil prices, environmental considerations (in particular, greenhouse gas (GHG) emissions — the Kyoto protocol) and the creation of single, competitive electricity and gas markets across the EU have been the major drivers in shaping EU energy policy. The more recent oil price volatility, along with disruptions in supply via pipelines of Russian gas have made energy reemerge as a major preoccupation of the EU and it's Member States. In response to this, the Commission published a Green Paper on energy where sustainability, competitiveness and security of supplies are defined as the three dimensions of energy strategy. The key challenges for EU energy policy are:


- Completing the internal market, with the creation of a competitive energy supply across the EU and ensuring that distribution and transmission systems allow equal access to third parties;
- Diversification of the fuel mix in electricity generation to foster sustainability, with the promotion of combined heat and power plants (CHP) and renewable energy sources;
- Promotion of energy efficiency in energy end use;
- Promotion of biofuels in transport with a beneficial effect on security of supplies and emissions.


In order to meet the increasing requirements of policymakers for energy monitoring, Eurostat has developed a coherent and harmonised system of energy statistics. Annual data collection covers the 25 Member States of the European Union, as well as the acceding countries of Bulgaria and Romania (which became EU Member States on 1 January 2007), the candidate countries of Croatia and Turkey, and the European Economic Area countries of Iceland and Norway; time-series run back to 1985 for some countries, but are more generally available from 1990. Although not presented in this yearbook, monthly data are also available; these have, in principle, the same geographical coverage as the annual data.

There is an increasing demand, not only within the European Community, for meaningful and accurate information on the consumption and use patterns of plant protection products. This publication presents the second update of the report from Eurostat on 'The use of plant protection products in the European Union', including for the first time figures for 10 new Member States for the four years preceding their accession to the EU in 2004. It provides statistical information on the estimated consumption of plant protection products, broken down by Member States, treated crops, chemical classes and active substances. Meaningful and reliable data on the use of plant protection products are necessary to monitor the risks related to their use, in particular the risks for the environment. Such data will become an essential tool to measure the progress of the thematic strategy on the sustainable use of plant protection products are delivered by the Member States on a mandatory basis, the estimations of use provided by the European Crop Protection Association (ECPA) are very useful since they are the only detailed data available at crop and active substance level; with the exception of the very few official surveys carried out in some Member States.
