The internal users of the Commission can access the **New Cronos database** through Europa-Plus. The external users can address their requirements to one of the Eurostat **Datashops**. This is a network of sales offices installed by EUROSTAT, in co-operation with National Statistical Offices, in the different EU countries and in some cities outside the Union.

**SBS data for candidate countries**

*theme4 Industry, Trade and Services*

*Domain : SBS Structural Business Statistics (Industry, Construction, Trade and Services)*

The SBS domain of New Cronos has recently been reshaped with a view to disseminating SBS data for candidate countries. SBS data will be available for the 10 Phare countries: Bulgaria, Czech Republic, Estonia, Hungary, Latvia, Lithuania, Poland, Romania, Slovakia, Slovenia, as well as for Albania and Cyprus.

The main SBS tables have been split into two tables. The first one is dedicated to Member States (including also Norway, Japan, and some first data from Switzerland within the short term). It corresponds to the previous SBS tables that have been renamed by adding MS. For instance enter becomes enter\_MS.

The second one is dedicated to candidate countries. It bears the name of the previous SBS tables followed by CC. For instance enter becomes enter\_CC.

First SBS data for candidate countries is available on NewCronos since November. These first SBS data for candidate countries are national data, available under table enter\_CC (collection enterpr). SBS data broken down by size class (collection sizclass) and regional data (collection region) will also be available.

Candidate countries data for reference year 1999 will be available in the beginning of 2002 and preliminary data for reference year 2000 in the spring of 2002.

Methodological notes similar to the ones currently available for Member States, will accompany each table. It has to be mentioned that monetary data will be expressed in millions of ECU (same currency as the one used for MS data), the exchange rate of the national currency vis-à-vis the ECU being given in the methodological notes.

\* *The reason why there is no data beyond NACE 45 is due to the fact that the current Structural Business Statistics Regulation does not require the countries to send data on enterprise births and deaths for trade or services. I would like to emphasize that the data that is currently there is not at all harmonised, and the project to develop data on business demography is ongoing. New harmonised data should be available by the end of this year.*

## RECENT SEMINARS

- *Working Group Information Society Statistics, 11-12 October 2001*

Eurostat presented a strategy document on Information Society statistics, which had been submitted to the SPC meeting in September 2001. Member States agreed to the work programme proposed therein. The rolling two year programme will be updated for the Task Force meeting in February 2002.

Eurostat made an inventory of publications and activities in the field of Information Society statistics available, which will also be regularly updated.

The results of the e-commerce pilot surveys 2001 were examined in the light of the preparation of a new round of surveys in 2002. All 15 Member States will participate in the 2002 e-commerce survey round. A large number of participating countries will carry out the surveys in the first quarter 2002, first results should be available at the end of the second quarter.

The Working Group also looked at the list of variables and the outline for a harmonised household survey on the use of information and communication technologies. 11 Member States will carry out the proposed household surveys on ICT usage, mostly in the second quarter 2002.

Member States were requested to comment in writing on a Eurostat proposal for an interim modification of the breakdown of the NACE and CPA classifications concerning the Information Society domain. The aim is to produce a proposal in 2002 which Member States could then implement on a voluntary basis in order to cover user needs better. The next regular revision of NACE and CPA will take place in 2007.

Eurostat presented the project of preparing a legal basis for Information Society statistics in the form of a framework regulation with modules. Member States were not strongly opposed against the idea of a legal act but asked for further clarifications. Member States were requested to comment on this proposal by the end of November 2001, a more specific proposal will then be presented to the Task Force in February 2002.

The next Working Group meeting will take place 17-18 June 2002, and a Task Force meeting is foreseen for 13-14 February 2002.

- *Working Group on Business Demography, 17 October 2001*

The main objective of the meeting was to exchange experiences and good practices on the feasibility study on Business Demography statistics and to refine methodology if necessary. Ten Member States, Norway and Switzerland participated in the meeting. The discussions centred on:

the concept of stock of enterprises

tools used for the verification of activity of enterprises

the matching process of different units in order to eliminate enterprise creations or deletions that are not real enterprise births or deaths

imputation of missing variables once activity status has been verified

the transmission format of the data to be delivered from the feasibility study

the outline for the methodological report to be delivered together with the data

It was concluded that no revisions to the methodology are necessary at this stage and that the feasibility study is well under way in the participating countries. An agreement on the transmission format of the data and on the outline of the methodological report was reached. The feasibility study results, both the data and the methodological report, are to be sent to Eurostat by 31 December 2001.

The analysis of the feasibility study results and the subsequent conclusions for the harmonised data collection will be done in the next Working Group on Business Demography to be held 17-19th of April 2002 in Luxembourg.

- *FEBI Meeting, 7 November 2001*

The 28th meeting of FEBI-FEBS (European trade bodies in industrial and service sectors) took place on 7 November 2001 in Luxembourg under the Chairmanship of Pedro Diaz. Following a summary by the Chairman of current developments in EU business statistics, the meeting considered ways in which future working relationships between Eurostat and FEBI members might be improved. A series of proposals which had emerged from earlier discussion at the FEBI Consultation Group were discussed and agreed: smaller ad hoc meetings on specific issues of interest; Eurostat to provide speakers on statistical issues at individual FEBI meetings; plenary sessions to be reduced to one meeting a year, to be held in November in Luxembourg; and Eurostat to encourage the addition of new members for the Consultation Group.

Discussion on statistical issues for the remainder of the meeting was wide-ranging and touched on the following topics:

Members noted important changes in the sources of data needed to compile balance of payments statistics - these were expected to increase the need for business surveys in this area. A progress report would be put before the November 2002 meeting.

On revisions to NACE and CPA (minor changes agreed for 2002 and a more substantial revision planned from 2007), members were invited to submit proposals for 2007 during the period mid 2002 to mid 2003. An important aim of this work was convergence with North American classification schemes. At the request of members, Eurostat agreed to add a detailed reconciliation of activity and product classifications to the Febinet web site.

On revisions to the Harmonised System (HS), also due for 2007, the main areas of debate concerned means of access by FEBI to early versions of the emerging scheme, how new cut-off threshold would be applied, and how members could establish contact with the lead policy DG (TAXUD).

On labour statistics, members learnt of developments in surveys on Labour Costs and Job Vacancies, and how these related to similar information available from the Household Labour Cost and SBS surveys.

The meeting noted important developments in environmental statistics, and discussed the complex issues facing those compiling relevant indicators and environmental targets.

Prodcom and trade figures were discussed together, with emphasis on improvements arising from the proposed use of the Comext system. Topics discussed included the problems of confidentiality and suppression of results and the relationship between Prodcom and CPA. Eurostat confirmed that members would be kept informed of both Prodcom and trade statistics at future meetings.

Finally, the meeting noted plans for Eurostat dissemination policy, and more specific proposals on the publication of business statistics.

## **Introduction to the Legal Framework of the European Business Statistics System**

The **legal acts of the Council** as well as the corresponding measures for implementation (that have normally the form of **Commission legal acts**) establish the framework for the production of harmonised business statistics.
