Context

In the previous nomenclature of the budget, the comments associated with the budget lines covering the grants financed under heading V (Administration) of the multi-annual financial framework used to request a report on their implementation.

This remark is no longer present in the new budget nomenclature. However past experience has shown the report to be a valued source of information to answer various questions raised by MEPs or citizens.

The report reviews the grants "ex A-30" financed under heading V and covered by basic acts which have been adopted by the Council (decisions) or the Council and the Parliament (co-decisions) end of 2003 and beginning 2004 (see table in enclosure 1).

Implementation under these basic acts lasted from 2004 to 2006 and can be considered as completed although some payments and recovery orders might still take place.

It has therefore been decided to produce for the last time this report; in order to maintain high level of transparency it follows the same structure as in previous years.

Under the 2007-2013 financial perspectives, the grants will follow the legal basis as of enclosure 2.
