Dear Asger Andreasen,

Thankyou for the opportunity to give input to the Commission Green Paper "Improving the mental health of the population:Towards a strategy on mental health for the European Union". It is the opinion of Region Västra Götaland that the mental health of the European population will be a crucial part of a successful sustainable development and growth.

The initiative from the Commission to the Green Paper as a response to the invitation from the 2005 WHO European Ministerial Conference on Mental Health, in order to launch a debate among members and European actors in the field of Mental Health is welcomed.

However, the suggested and outlined strategy is lacking an adequate regional perspective and this will jeopardise the good intentions described. Since in many member states the responsibility for planning and management of Mental health service as well as preventive and promotive initiatives is in the hands of the regional and local level authorities it is crucial that a subnational perspective is reflected in the developing strategy. The Green Paper is focused on the interface between the national level and the Community visavi the Institutions, "health professionals, stakeholders in other sectors, civil society including patient organisations, and the research community..." but not the regional and local levels. That is a potential pitfall. The regions in collaboration with the local level has important knowledge and knowhow for the planning and influencing on mental health determinants.

Therefore the EUREGHA initiative is important and might play a role in strengthen the regional perspective in this process.

As the theme for the Thematic meeting is section 6.3 on information and knowledge, we strongly agree with mr Ljungberg that the regional level is adequate for developing epidemiological aspects on information systems on mental health. It is important that information and indicators reflect the inequalities there are in mental health between member states but also within member states. Otherwise information systems will lack the power needed for decision makers to know whether interventions and initiatives will reach the most vulnerable groups in the Community.

For this reason an information system on mental health in Europe should comprise relevant indicators which reflect the distribution and variation of mental health determinants within populations and involve regional and local authorities in collaboration with the research communities, the latter as mr Ljungberg states, already has links to regional level.

The next Thematic Meeting on the Green Paper will be held in Luxemburg on May 18 and 19, 2006. The theme will be section 6.3 in the Green Paper "Improving information and knowledge on mental health in EU".

Mr. Lars-Olof Ljungberg says in the attached report:

"My planned input from a regional and local perspective to that meeting is that there are quite often a lot of information available in regions around mental health

services (beds, costs, staff, visits to out-patient clinic, unvoluntary admissions etc). Unfortunately these data are collected in different ways in different countries

which akes comparison difficult or impossible. There are some data on mental ill health (epidemiology, incidence, prevalence) but substantially less on mental

health. There needs to be developed and agreed upon indicators on mental health that could be used across Europe.

The regional level is adequate for this task since it has the capacity to do this, and also has the necessary links to academic institutions. I appreciate any

comments on this report and suggestions for the upcoming Thematic Meeting".
