Data summary

We principally adopted the list of Eurostat contact (Eurostat partnership on health statistics). For all sixteen designated European countries, the letter of data request was firstly sent on 12 June 2006. Most of the countries sent the data to us without tabulation, such as Austria, Belgium, Czech Republic, France, Italy, Switzerland, and Slovenia. So the dataset has to be reprocessed in order to create a column for « number of death » (and not one line by individual). Data cleaning processes and manipulations were set upon the receipt of the data. Nevertheless, in order to ensure the data quality and consistency, we cross check the total number of monthly mortality with that of Eurostat.

Table 1 shows the summary of the data collection indicating the receipt date of dataset, the format of dataset, the reference period (1998-2002) and the latest available period (from 2003 to 2004/5). It also summarizes whether NUTS 2 area is provided and the amount of payment. Table 2 provides a list of data providers.

For Austria: Ms. Barbara Leitner (Eurostat Contact). The dataset amounted to 201Euros. The last e-mail was on 4 July 2006. Nine NUTS 2 areas are provided. The number of monthly mortality is exactly as the same as that of Eurostat.

For Belgium: Mr. Herman van Oyen and Ms. Bianca Cox (are not in the Eurostat Contact). The data was free. The last e-mail was on 23 August 2006. Twelve NUTS 2 areas are provided. Initially, we found some problem of the dataset that did not yield the same total number of monthly mortality as shown in Eurostat. It was because the dataset we received only covering the persons died in Belgium. Therefore, we contacted Ms. Cox again and confirmed with her the same monthly mortality totals on 19th January 2007.

For Croatia: Mr. Robert Jurak and Ms. Maga Francic (not Eurostat Contact). The dataset firstly amounted to 2,500Euros. Then, a rebate letter was sent. Mr. Jurak replied to us with a new offer (60Euros) but with a wrong payer. After fixing this problem, we finally paid 300Euros for the requested data. Due to the fact that Mr. Jurak was seriously ill, our request was tardily transferred to Ms. Francic. Consequently, the data was obtained on 8 December 2006. There is no NUTS2 area in Croatia, only NUTS1 or NUTS3. The data was given with NUTS3, so it was regrouped by NUTS2 area. The total number of monthly mortality is exactly as the same as that of Eurostat.

For Czech Republic: Ms. Terezie Kretschmerova (Eurostat Contact). The data was free of charge. The last e-mail was on 20 June 2006. Eight NUTS 2 areas are provided in the dataset. There is no discrepancy of the total number of monthly mortality between Eurostat and our dataset.

For Denmark: Mr. Jesper Marcussen (Eurostat Contact). The dataset amounted to 536Euros. We obtained it on 25 October 2006. When we cross checked the number of monthly mortality

with that of Eurostat, we found some minor discrepancy in the dataset. We have contacted Mr. Marcussen again, but no reply is received from him so far related to this issue of the discrepancy. The dataset is provided only for NUTS1.

For France: We firstly contacted Mr. Gérard Pavillon (Eurostat Contact) whom later transferred our request to Mr. Eric Jougla (his director, the right contact). The dataset with a CD-ROM format was received in August 2006. The dataset was free of charge. There is a slight discrepancy of the total number of monthly mortality between Eurostat and our dataset. However, the dataset we received is exactly as the same as that of CépicDc. The slight discrepancy with Eurostat is due to the fact that the dataset for Eurostat comes from INSEE. Twenty-two NUTS2 areas are provided in the dataset.

For Germany: We have initially contacted Mr. Torsten Schelhase (Eurostat Contact) whom forwarded our email to Mr. Stefan Rübenach (the right contact). At the beginning, the dataset amounted to 6,500Euros because it was explained that the dataset was gathered individually from sixteen Länders in Germany. The requested data is compiled on our research purpose. Nevertheless, a rebate letter was sent to Mr. Rübenach. A reduction of the payment was given. We finally paid 5,500Euros and received the full dataset on 12 December 2006. The total number of monthly mortality is exactly as the same as that of Eurostat. Sixteen NUTS 2 areas are provided in the dataset.

For Italy: Ms. Silvia Bruzzone (Eurostat Contact) is the right person-in-charge of ISTAT. We obtained the data (1998-2003) on 29 September 2006 without any charge. However, the total number of monthly mortality was not as the same as that of Eurostat. As explained by Ms. Bruzzone, the major reason is due to the fact that we received only the data with the day of known deaths. Thus, the dataset we received from ISTAT comprises fewer deaths than that of Eurostat. When we compared to the total number of monthly mortality computed by ISTAT, there is also a slight discrepancy due to missing data on sex and month of death. The 2004 daily mortality data will be available in April 2007.

For Luxemburg: We firstly contacted Dr. Yolande Wagener (Eurostat Contact) whom transferred our email to Mr. Guy Weber (the right contact). We received the data on 14 November 2006 without any charge. There is some discrepancy of the total number of monthly mortality between Eurostat and our dataset from Mr. Weber. But the number of monthly mortality is in line with that of the data provider. The dataset is provided only for NUTS1.

For Netherlands: We have contacted Ms. Ingeborg Deerenberg (Eurostat Contact) whom forwarded our request to Mr. Carel Harmsen (the right contact). Initially, the dataset amounted to 1,157Euros. However after the rebate letter was sent, the cost of dataset reduced to 261Euros. The whole set of data was received on 16 November 2006. The total number of monthly mortality is congruent with that of Eurostat. The dataset is provided only for NUTS1 area.

For Poland: The first contact was Ms. Lucyna Nowak (Eurostat Contact) but who transferred our email to Mr. Artur Satora (the right contact). Before the rebate letter was sent, the dataset amounted to 1,130Euros. After it was sent, the data was free of charge. The dataset with a CD-ROM format was received by the end of December 2006 with only NUTS3 area. The dataset was reprocessed to NUTS2 area afterwards. Sixteen NUTS2 areas are compiled. The total number of monthly mortality is exactly as the same as that of Eurostat.

For Portugal: We firstly contacted Ms. Judite Catarino who was not the right contact, so we later contacted Dr. Carlos Mathias Dias who forwarded our email to Mr. Victor Garcia. The person who replied was Ms. Eduarda Góis (she works with Mr. Victor Garcia). A full set of requested data was received on 28 September 2006. The data was free of charge. Seven NUTS2 areas are provided in the dataset. Although the total number of monthly mortality provided is different from that of Eurostat, we have the same totals as given by our data provider. As explained, the monthly mortality data covers only those who died in Portugal with residence. Those who died outside abroad with residence are excluded. This can explain the discrepancy of the total number of monthly mortality between Eurostat and our dataset.

For Slovenia: We contacted Ms. Josica Selb who later forwarded our reply to the director of the Institute and the Chief of the Statistical Unit. We obtained a reply from Mr. Tatjana Rokavec with the supply of data on 10 November 2006. The dataset amounted to 700Euros and was provided only for NUTS1 area. There is no discrepancy of the total number of monthly mortality between Eurostat and our dataset.

For Spain: Ms. Raquel Álvarez Esteban (Eurostat Contact) was the right contact. The dataset with a CD-ROM format was received by the end of September 2006. The dataset was compiled for nineteen NUTS2 areas. It cost 361Euros. The total number of monthly mortality is exactly as the same as that of Eurostat.

For Switzerland: We firstly contacted Mr. Christoph Junker who forwarded our request to his team members. A form of protection data contract was signed and returned to them. The person who proceeded our data request was at the e-mail of <u>Dominik.ullmann@bfs.admin.ch</u>. The dataset was received on 9 October 2006 without any charge. Twenty-six NUTS2 areas are divided in the dataset. There is a slight discrepancy of the total number of monthly mortality between Eurostat and our dataset, but the result is in line with that of our data provider.

For United Kingdom: Ms. Clare Griffiths (Eurostat Contact) provided the dataset on 24 August 2006. It cost 220Euros. Thirty-two NUTS2 areas are compiled in the dataset. Compared to the total number of monthly mortality with Eurostat, we found we had fewer total number of monthly mortality given by ONS. It is because the dataset we received covers only for England and Wales, not for the United Kingdom. However, when we compared those of 1998-2001 from ONS website, the annual numbers of mortality data are consistent with the ones we received.
