1.1. ICCG group

Information on the role of EP STOA committee

The role of STOA in the Parliament and its activities were presented in the ICCG meeting. The STOA representative expressed interest for intensified cooperation with the non-food Scientific Committees of the Commission.

The SC members were interested about the decision making procedure for projects where scientific advice from a neutral body could be useful and considered important to establish formal contacts and ensure discussion of various issues.

Revision of the Scientific Committees

The Chairman reported that the revision of the Scientific Committees has been finalised will be sent for the Inter Service Consultation to EC Directorates. The current three Committees will be maintained with expanded mandates taking into account the future needs of the Commission and reducing the SCHER activities on issues that will be moved to the European Chemical Agency (ECHA).
