




State Cooperation



- Bilateral agreements between Germany and different Countries






Focal Country

- highest rates of new infections in Europe
- existing cooperations of several German NGO's
- The German Government has planned to allocate between 2007-2010 around 7 Million EUR for the bilateral cooperation with Ukraine in the field of HIV/AIDS






Characteristics of the Cooperation

- Capacity Development, Knowledge Transfer






Coordinated Response

- Information and exchange about activities between the countries






Regional focal points

- Region Donetsk






National Government

- Cooperation between the German and the Ukrainian Ministry of Health (MoH)
- Focus on Assistance to build up a national HIV/AIDS Prevention Strategy and a national Prevention Campaign
- Twinning-Model. German expert is directly working for and with the staff of the MoH. Germany is financing two additional Ukrainian experts for the team of the MoH






Selected Cooperations in the field of Prevention (I)

- Post-Graduate Further Education for teachers on the topic of HIV/AIDS - development of modules for further education between the Freiburg Catholic University of Applied Sciences and the Institute for Postdiploma Further Education for teachers in the Chernivtsi Region
- Support of a multisectoral coordination and intervention strategy development in four regions of Western Ukraine: Vinnytsia, Khmelnytsky, Ternopil und Chernivtsi. Prevention in educational establishments, harm reduction, medical and social services for PLWHA






Selected Cooperations in the field of Prevention (II)

- Mapping of the situation and concept development of the HIV prevention among men who have sex with men through the cooperation of Connect plus e.V. and the Gay Alliance Ukraine
- Knowledge transfer for the development and implementation of a curriculum for the qualification of social workers as well as for the establishment of a network of multipliers through the cooperation between Connect plus e.V. and the State Social Services (Supported by the Robert Bosch Foundation)








Selected Cooperations in the field of Diagnostics and Treatment


- Clinical Partnership between the AVK-Clinic in Berlin and the Aids Center in Donetsk
- Clinical Partnership between the HIV-Center of the University of Frankfurt and the Lavra Clinic in Kviv






Cooperation in the field of Care

 Support for the development of tools and standards for Care in Clinics and for home care. Cooperation between Caritas International and Caritas Ukraine






Future prospects


Germany is financing the BORDERNETwork Project since 2008. BORDERNETwork provides Crossborder Cooperations in 7 Countries:
