# Objective



**To produce an indicator based report on the monitoring of progress in implementing the actions set out in the Dublin Declaration to Fight HIV/AIDS in Europe and Central Asia.**

# Principles



- **Build on previous work – especially the earlier WHO report**
- **Indicators need to be simplified and streamlined**
- **Indicators must be relevant to the European context**
- **Data collection should be harmonised with other processes, e.g. Commission reporting, UNGASS**

# Dublin Declaration



- **Thirty three actions...**
- **In five areas:**
  - **Leadership (7)**
  - **Prevention (12)**
  - **Living with HIV (6)**
  - **Partnership (7)**
  - **Follow-up (1)**
- **Overlap between 'leadership' and 'partnership'**

A good indicator should meet the following five standards:

1. The indicator is needed and useful.
2. The indicator has technical merit.
3. The indicator is fully-defined.
4. It is feasible to measure the indicator.
5. The indicator has been field-tested or used operationally.

In addition, where indicators are presented as a set, it should be coherent and balanced.
