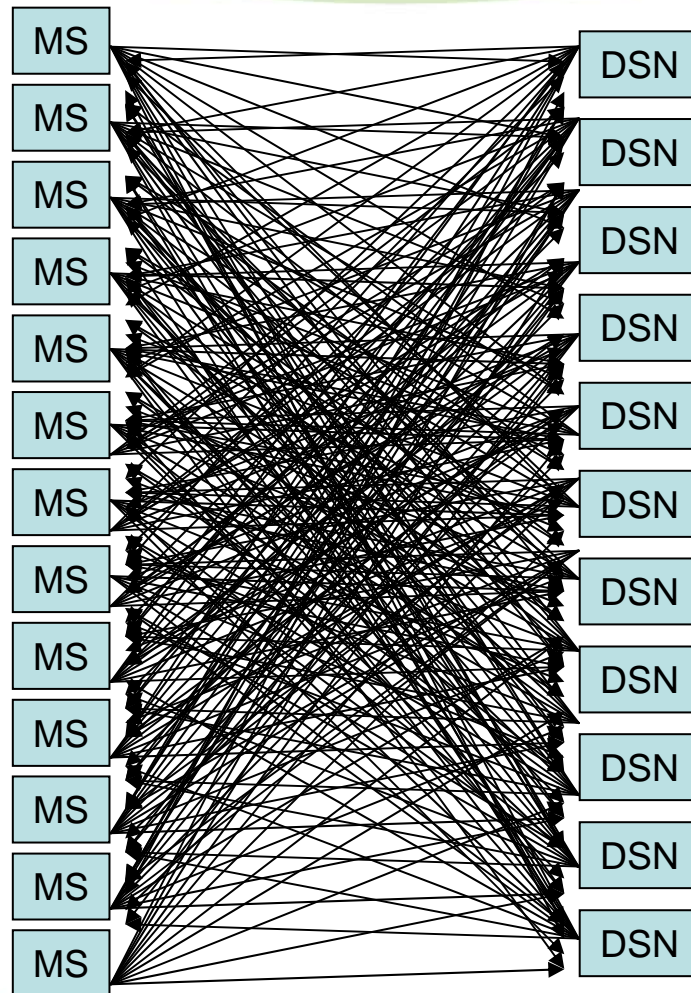
# EU communicable disease surveillance



- **EU-wide surveillance is not new**
  - first surveillance network, EuroHIV, dates back to 1980
  - 49 communicable diseases now under EU-wide surveillance
  - Council Decision 2119/98, Commission Decision 2003/542/EC
- **.. But creation of ECDC changes, and strengthens, system for carrying it out**
  - Mandate to carry out or fund surveillance
  - Maintain the surveillance database(s)

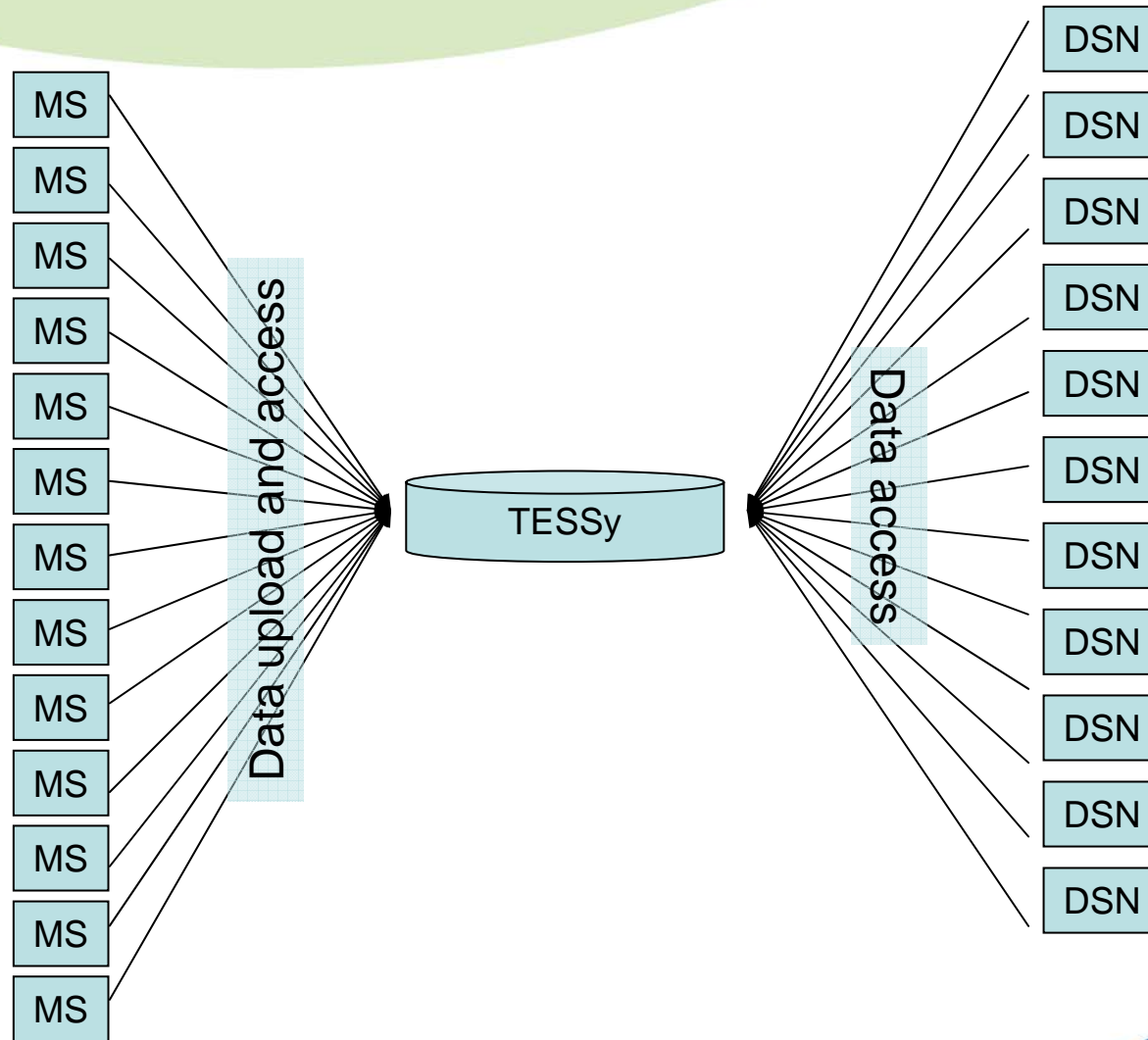


# The old system



- Basic Surveillance Network
  - All 49 diseases ± covered
  - Limited set of variables
- Disease specific “Dedicated Surveillance Network”
  - 20 diseases in more detail
  - Data sets vary from network to network
  - Countries covered vary
- **RESULT: Many data sets, many databases**

# The future – a single EU surveillance database (TESSy)

Welcome to the TESSy web site!

TESSy is The European Surveillance System, a central repository of surveillance data in the European Union.

In this system you can choose to do the following:

- **Download data:** Dynamical creation of an extract of case records to be viewed or to be saved in a file for further processing.
- **View Reports:** A fixed set of reports are offered containing aggregated information, i.e. number of cases or distributions.
- **Upload data:** Submit data in CSV och XML format that will be available in TESSy.
- **Review uploads:** Review and approve validated batches.

  - print version in August

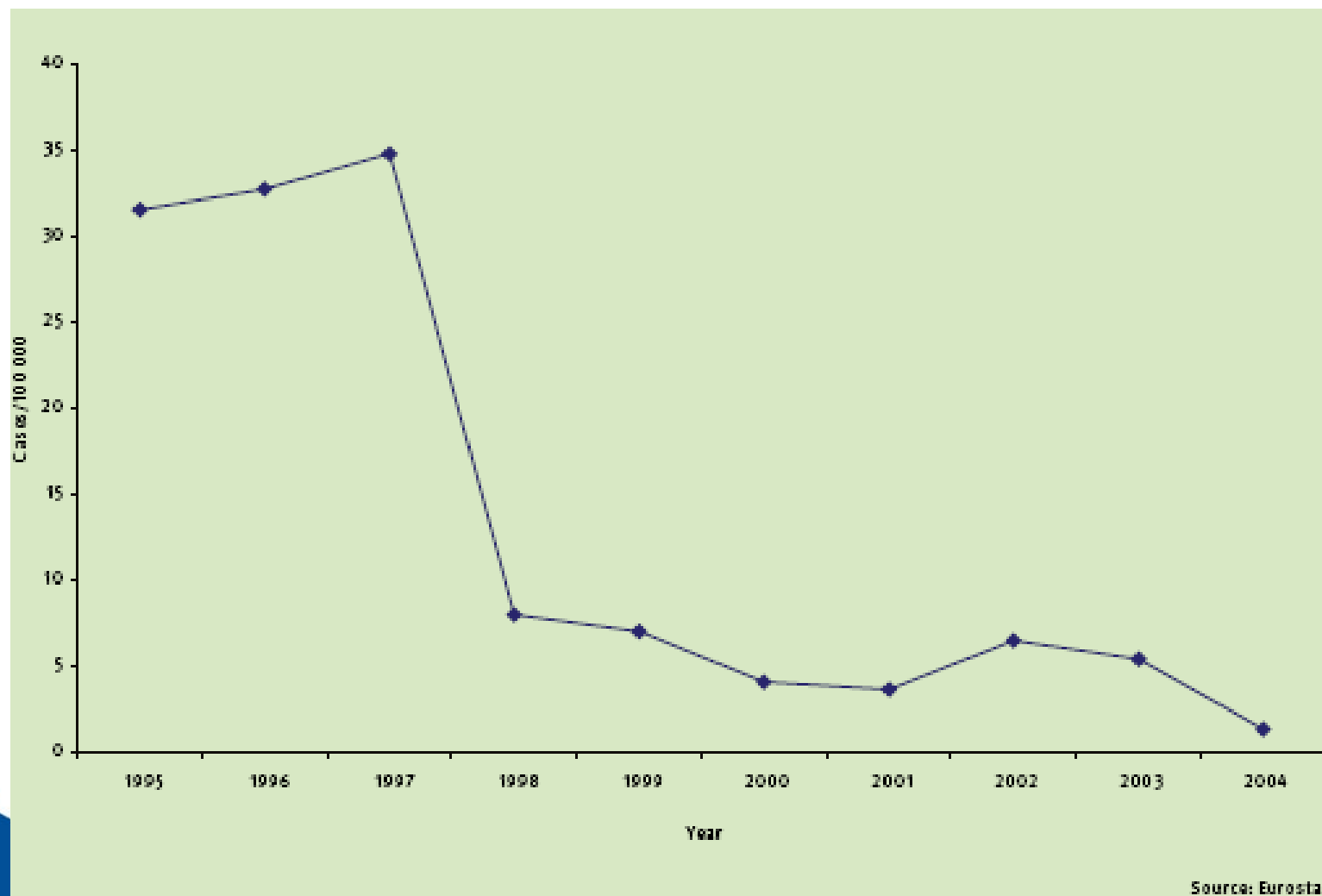
\* 12 page report is being translated into all EU official languages, Icelandic and Norwegian

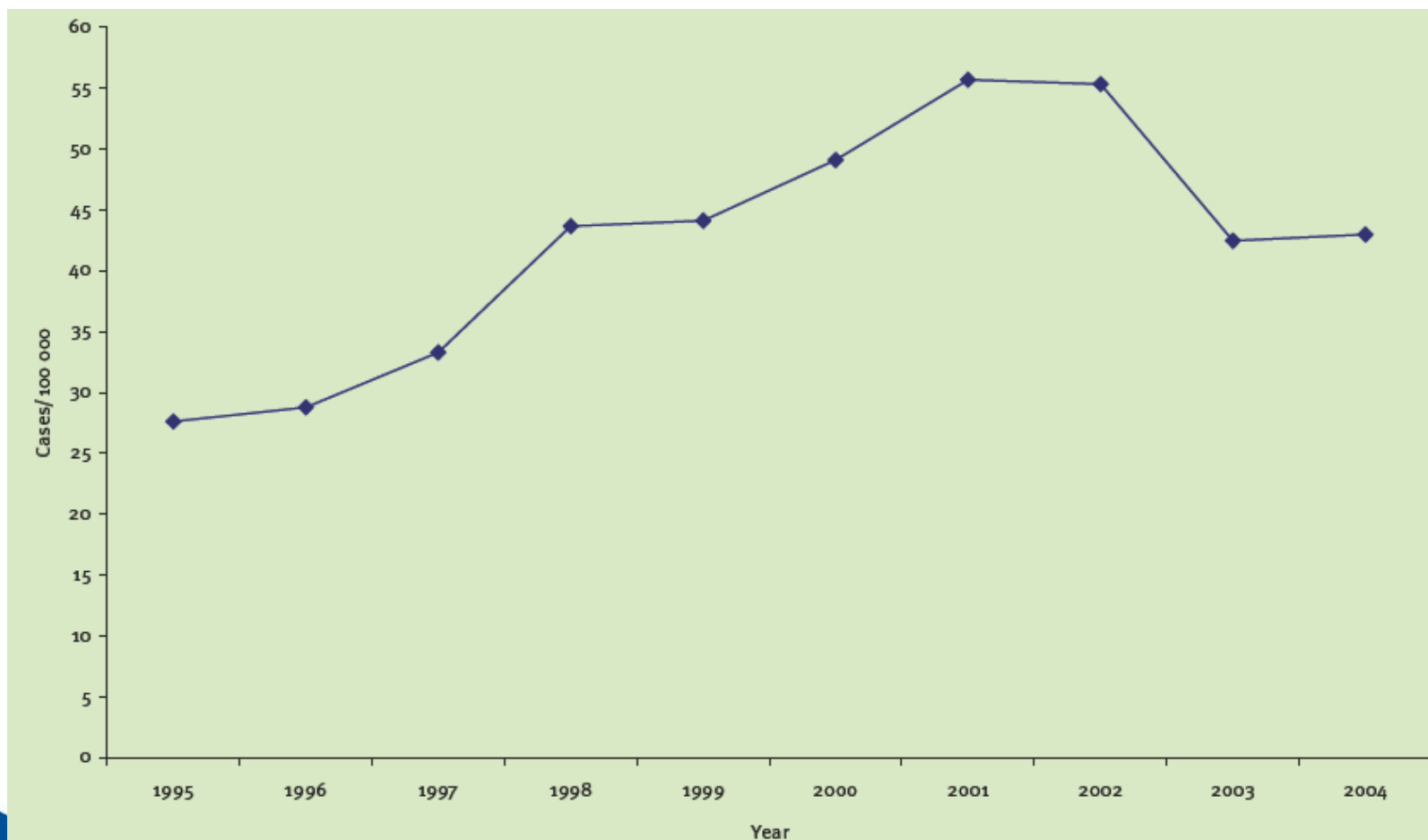
- 49 infectious diseases
