1. WELCOME AND APOLOGIES

The Chair welcomed the participants. One apology was announced by the Chair.

2. ADOPTION OF THE AGENDA

The Chair requested participants to declare any conflict of interest regarding matters on the agenda. None of the participants declared any conflict of interest.

5. INFORMATION FROM THE CHAIR, MEMBERS AND THE COMMISSION

- Appointment of five new external experts: after the open call for additional SCCS experts (closed on 11 January) and consultation with SCCS, the Commission has appointed five new experts to join the working groups (WGs) and four were already welcomed at this meeting. Other suitable experts will remain on a reserve list until the end of the term.
- The Commission informed about the coming written procedure for adoption of nano silica Opinion (mid-March). The Opinion is planned to be finalised during next nano WG meeting on 13/03.
- The Commission informed that Formaldehyde SCCS opinion has been accepted for publication in the Regulatory Toxicology and Pharmacology scientific journal.
