There is significant interest from individual citizens, associations, the media and the political world in the progress being made in the implementation of Decision [2007/116/EC](#) and Decision [2007/698/EC](#).

This document gives an overview of the state of implementation for 116000, 116111, 116123, based on data collected in February and March 2008 (see request in document COCOM 08-06).

Member States are required to reserve the 116 numbers, but there is no obligation for them to actually provide the services. Once the necessary national *preparatory steps* have been taken, they are also required to announce that the *number is available* for the provision of the service and that applications for rights of use for these numbers may be submitted. The MS deadline for 116000 was that by 31 August 2007 NRAs should have been *ready* to assign the number to an appropriate organisation. For 116111 and 116123, NRAs should have been ready by 29 February 2008. It is then the task of the national regulators (NRAs) to assign the number to an appropriate service provider that is willing and able to handle the calls, following a national procedure. For example, in some Member States, the NRA simply awaits applications. In other Member States there is a call for interest/tender. The next step after assignment is the actual launch of the services via 116000, 116111 and 116123. This clearly depends on the service provider designated in the Member State, and is outside the control of the Commission.

The detailed data are available in the annex, and can be summarised as follows:

For 116000:

- 6 MS (BE, DK, EL, HU, NL, PT) have assigned 116000;
- The number assignment is ongoing in 3 MS (CZ, FR, SK);
- The number is available for assignment in 14 MS (AT, BU, CY, DE, EE, ES, FI, IE, LT, LU, MT, PL, SE, SI).

For 116111:

- 6 MS (CZ, DK, FI, HU, PT, SE) have assigned 116111;
- The number assignment is ongoing in 3 MS (BU, EL, SK)
- The number is available for assignment in 14 MS (AT, BE, CY, DE, EE, ES, FR, IE, LT, LU, MT, NL, PL, SI)

For 116123:

- 4 MS (FI, IE, SE, SI) have assigned 116123;
- The number assignment is ongoing in 1 MS (DE);
- The number is available for assignment in 18 MS (AT, BE, BU, CZ, CY, DK, EE, EL, ES, FR, HU, LT, LU, MT, NL, PL, PT, SK).

In other countries, the number is not available yet or there is no information on the current state of play. Delegations should be prepared to give information orally on the above points at the COCOM meeting of 23 April 2008.
