# CEF programme in Telecom

## Objective

*to facilitate cross-border interaction between public administrations, businesses and citizens, by deploying digital service infrastructures (DSIs) and broadband networks.*

## Period

*2014-2020 (current Multiannual Financial Framework MFF)*

## Budget

*1.0 Billion euro*

## CEF and Europeana (legal base)

As **well-established digital service infrastructure**, Europeana and Safer Internet for Children should have **priority for funding**. In particular, the continuity in Union funding from other Union programmes to CEF should be ensured **in the first years** of the multiannual financial framework for the period 2014-2020 laid down in Council Regulation (EU, Euratom) No 1311/2013 (3) in order to allow for uninterrupted and successful delivery of service at the same level as provided for under the current funding scheme.

# Services Funded by CEF

## Core Service Platforms

central hubs of digital service infrastructures aiming to ensure trans-European connectivity, access and interoperability, and which are open to Member States and may be open to other entities

## Generic Services

gateway services linking one or more national infrastructure(s) to core service platform(s)

Priority is given to Core Services

## **CEF WP 2017**

***Core Services*** – 14 MEUR for min 2 years to maintain and further develop Europeana platform.

***Generic Services*** – 2 MEUR (75% funding) for user-oriented projects. Call opens June 2017 closes November 2017



# Preparation of 2018 Work Programme

*March-April 2017 MS requested to provide input on 2018 Work Programme Generic Services:*

- improve already available material and make available new high-quality material, including through digitisation*
- enhance the structure and richness of metadata to increase its searchability and findability*
- demonstrate its potential for reuse through the development of concrete applications in research or other sectors.*

- *Adoption by the Commission on February 2018*
