

# Objectives of the assignment Original objectives

#### The objectives of the study are twofold:


- **1)Evaluate** the functioning of the PSI Directive (with respect to the 2013 additions) based on the state of play regarding the re-use of public sector information in a representative number of EU Member States (10 countries).
- 1)Assess the expected impacts of a limited number of options for policy interventions, as well as compare the different options (or combinations thereof). In particular, these options should be considered:
  - Extending the PSI Directive to data held by research bodies
  - Extending the PSI Directive to data held by para-public bodies (indicative definition → Directive 2014/25/EU on procurement by entities operating in the water, energy, transport and postal services sectors and repealing Directive 2004/17/EC)
  - Modifying the charging provisions
  - Further promoting the take up of APIs
  - Further promoting the opening up of dynamic data



# Scope of the assignment Geographical coverage


The assignment will cover the **28 Member States**. However, for the data collection, the following Member States have been chosen for in-depth analysis:

- Ireland
- Italy
- Poland
- Slovenia
- Estonia
- Sweden
- Germany
- Netherlands
- Greece
- France

### Methodology


#### Member States fieldwork

For the economic data collection and analysis, the team will carry out up to 20 interviews for each of the 10 Member States indicated above and will also carry out in-depth desk research.

These data will also be combined with the outcome of the surveys (see next slide).

Interviews will be organized with different stakeholders such as:

- Ministries and public bodies in charge of public sector data regulation and monitoring of implementation
- Public bodies falling into the scope of the directive
- Museums, libraries, archives
- Para-public bodies
- Universities and research centers
- Re-users associations



### Methodology

### Stakeholders surveys

The team will carry out 3 different online surveys targeting 3 different communities:

- Survey on cultural data: this survey will feed the evaluation and the analysis of the effects of the new provisions established in 2013 with respect to data held by museums etc. It will be disseminated through Europeana and other cultural networks.
- Survey on research data: this survey will investigate the effects and opportunities linked to the opening up of research data (in the framework of publicly funded research). It will target universities and research centres.
- Survey for the re-user community: this survey will focus on the beneficiaries of the PSI Directive and will concern mainly:
  - The provisions on charging (marginal cost) and the effects of possible modifications to this provision
  - The possibility of opening up data held by para-public bodies or produced in relation to public contracts
  - The possibility of opening up research data
  - The question of APIs and dynamic data



# Stakeholder engagement Workshops

In order to engage stakeholders and validate the data, the team will organize **three different workshops** in the coming months:

- A first workshop on Research Data on December the 14th. This
  workshop will target research bodies primarily and will help
  discussing the potential and challenges related to opening up
  research data.
- A second workshop on para-public bodies in January (date still to be defined). This workshop will target para-public authorities in the domain of energy and transport primarily and will discuss the potential for opening up and reuse of the data they hold.
- A Final workshop with number of high level stakeholders (both policy makers and other interested parties) at the beginning of March to validate and discuss the final output of the study (also in light of the Regulatory Scrutiny Board opinion on the IA)


