1. Description

The processing of personal data concerns email addresses of individuals interested in JRC's Industrial Research & Innovation project and its contribution to EU innovation policies. In relation with the Europe 2020 Strategy for the purpose mentioned under point 2 below, this processing is managed at the Joint Research Centre (JRC) by the *Directorate B (Growth and Innovation), Unit B3 (Territorial Development)*.

As this processing collects and further processes personal data, Regulation (EC) 45/2001, of the European Parliament and of the Council of 18 December 2000 on the protection of individuals with regard to the processing of personal data by the Community institutions and bodies and on the free movement of such data, is applicable. The Unit Head of "Inter-institutional, International Relations and Outreach" acts as Controller of the processing of personal data covered by generic notification "CONTACTS LISTS & NETWORK PARTNERS DATABASES AT THE JRC" (DPO-1924). The JRC Unit Head of the *Communication Unit* manages the processing itself, under the responsibility of his Director who acts as Processor.

2. What personal information do we collect, for what purpose and through which technical means?

Purpose

Personal data are collected and processed in order to communicate with the data subjects about the *JRC Directorate B* research activities related to the Framework Programme for Research and Innovation (2014-2020).

Identification Data

The personal data collected comprise Identification data consisting of name, surname, job title, company/institution and email address.

Technical information

Personal data are normally collected through classical databases or Excel forms and stored on the JRC servers.

3. Who has access to your information and to whom is it disclosed?

Access to the personal data is allowed to authorized officials and other staff of the JRC. No personal data are transmitted to parties outside the recipients and the legal framework mentioned.

4. How do we protect and safeguard your information?

The collected personal data are stored on the servers of JRC and underlie the Commission Decision C (2006) 3602 of 17/08/2006 "concerning the security of information systems used by the European Commission", which defines IT security measures in force. Here, Annex I defines the security requirements of EC Information Systems, Annex II the different actors and their responsibilities and Annex III the rules applicable by users.

5. How can you verify, modify or delete your information?

The data subject can send a message to the Controller or to the address mentioned under "Contract Information" below, by explicitly specifying your request to have your personal data modified or deleted. Special attention is drawn to the consequences of a delete request, in which case any trace to be able to contact you will be lost.

6. How long do we keep your data?

Your personal data are kept as long as follow-up actions linked to the above mentioned purpose are necessary with a maximum of 4 years.
