Notes

1. The table does not include groups with their head office in Belgium, Greece, Portugal or Slovenia, as these Member States have not yet completed the process of notifying groups that they are considered to be conglomerates. The same applies to some groups with their head office in Austria and in France.
2. A final decision on the identity of RCAs is still to be confirmed.
3. Where Article 3.3 applies, the group in question has been identified as a conglomerate, but the coordinator and, where appropriate, relevant competent authorities may decide that the group should not be subject to some or all of the requirements of supplementary supervision as required by Directive 2002/87/EC.
