Where Article 3.3 applies, the group in question has been identified as a conglomerate, but the coordinator and, where appropriate, relevant competent authorities may decide that the group should not be subject to some or all of the requirements of supplementary supervision as required by Directive 2002/87/EC.
3. To be decided according to Directive 2002/87/EC and the Italian decree implementing the Directive.
4. A final decision on the identity of RCAs is still to be confirmed.
