EIOPC Members' Authorities

EIOPC members are appointed from the insurance supervisory and regulatory authorities of the 27 Member States. Each Member State may appoint up to two Members to the Committee; this may accommodate those States in which the supervisory and the legislative competencies in the field of insurance belong to the competence of different authorities (in most cases an independent supervisory authority and a ministry of finance or economic affairs). The level of representation on the EIOPC is of an appropriately high level nature for it to fulfil its tasks.

Representatives from Norway, Iceland and Liechtenstein have also been admitted into the EIOPC meetings as observers in view of the requirement of the Agreement on the European Economic Area on these countries to implement the EU insurance directives into their national law.
